Essential Job duties / Scope of Work: - Promote mental health and provide basic mental health and psychosocial needs to people with mental neurological and substance use conditions, care giver and families. Under the supervision of PHC Coordinator, the following specific tasks & responsibilities will be assigned to the Mental Health Officer through the

Duties and Responsibilities

- Assist the Mental Health Specialist / PHC coordinator with the integration of mental health and psychosocial support into general
- Provide psychosocial support services linked to general health care
- Select and provide training and supervise community psychosocial workers in project location assigned.
- Develop culturally appropriate psychosocial activities, including social support activities for targeted population. These include but are not limited to training in psychological first aid, designing holistic recreational, and social activities; development of material for awareness campaigns.
- Serve as a point of contact between IMC and local partners involved in psychosocial activities under the guidance of the MHPSS
- Strengthen community-facility referral system for refugees with mental and psychosocial problems.
- Work in keeping with IASC guidelines on mental health and psychosocial support and promote guidelines where appropriate.
- Work closely with other mental health and psychosocial staff to ensure coordinated activities.
- Collaborate with infonnal service providers such as natural healers to facilitate information sharing and referral of mental health cases.
- Collaborate with community and existing institutional structures to ensure protection of those suffering from mental illness.
- Keep records updated and share required information with MHPSS
- Compile information and prepare written reports as necessary.
- Organize public awareness and de-stigmatization campaigns around mental health issues with support from local staff including refugee
- Represent IMC in coordination meetings when assigned to do so by the MHPSS specialist or immediate supervisor.

Implement other activities as per the direction of the mental health specialist managing the MHPSS project.
