Job Title: RSRTF PROGRAM COORDINATOR (1 post)

ROLE PURPOSE: The RSRTF Program Coordinator will work closely with Area I CP Program Manager in planning implementing and coordinating project all project deliverables. The postholder is the primary contact person for RSRTF Project with all responsibilities to plan, implement, monitor and document the project. S/he will line manage and supervise the project human resources, and finances-as well as compiling donor reports. S/he is expected to ensure enabling environment for project activities including negotiating with authorities and community representatives, ensure organizations' full representation in working groups, clusters and line ministries.

In the event of a major humanitarian emergency, the role holder will be expected to work outside the normal role profile and be able to vary working hours accordingly.
