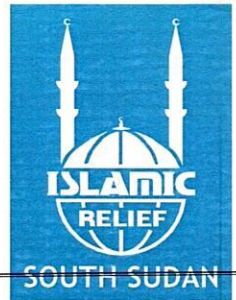
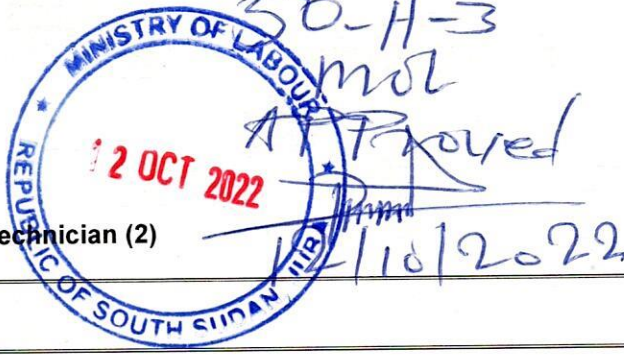

<b>PURPOSE OF DIVISION:</b> Through capacity building and through technical and programme support, the International Programme Division keeps the organization focused on the socio-economic and humanitarian needs of vulnerable people. <b>JOB PURPOSE:</b>  The WASH Technician will be responsible for providing support to the WASH team majorly on the hardware components of WASH program including drilling/rehabilitation of water facilities and develops; BOQs, drawing / designs and day to day supervision of field works to ensure contractors deliver quality infrastructure works. The WASH technician shall also be responsible for WASH software component in the area he or she may be assigned. Software components that includes but not limited to; hygiene and sanitation awareness activities, home visits/ home improvement campaigns, CLTS triggering and monitoring, trainings, WASH data collection, water source cleanliness, jerry can cleaning campaigns, etc.

- Work with WASH Officer to conduct continual review of WASH infrastructural designs and functionality of the water supply systems (and other water facilities) to ensure efficient operation as well as reliability and supply of clean portable water for the communities.
- Regularly monitor the village/IDPs and host community water supplies and estimate water requirement vis-à-vis the production of water from the BHs, wells and hand pumps within the area.
- The duty holder fully participates in the development of BoQs and designs for all WASH infrastructural works on the various projects including but not limited to latrines construction, water well drillings and latrine construction/ rehabilitations, etc.
- Provide rigorous supervision of WASH hardware works in the various project sites of IRW'S intervention.
- Provide technical supervision of contractors undertaking various IRW construction works and ensure all construction meet required standard.
- Conduct WASH assessments for new borehole drillings and rehabilitation activities in the field.
- Provide technical inputs in the development of IRW regular reports both internally and externally: Weekly, monthly, quarterly, annual, etc.
- Provide technical verification goods supplied by vendors before distribution to the right holders.
- Take lead in capacity building of Water Management and Sanitation committees especially with regards to routine maintenance techniques.
- Perform any other tasks that shall be assigned from time to time by the line supervisor or management.
