1. This Invitation for Bids follows successful submission of proposal for PHCCs and PHCUs renovation/construction (PFRM) Funded Project by World Bank under LOT 6 in Fangak County, Jonglei State in South Sudan.
2. HFO invites sealed bids from eligible and qualified bidders for supply of Assorted PHCC/PHCU renovation/construction materials under Invitation for Bid (IFB) No. HFO/SSD/PFRM /2019/01/01.

The Work is in four (4) different facilities as indicated in the table below

Bidders are requested to bid for a complete Facilities as requested in the render. Bidders can bid for as many different facilities as possible. Bid evaluation will be per the percentage and contracts will be awarded based on this percentage.

3. Qualification Requirement Includes:

- Eligibility:** the bidder must provide company legal documents e.g. certificate of incorporation, TIN/PIN, Trade license, company profile, tax clearance certificate, import license, etc.
- Financial Capability:** The bidder must demonstrate access to or availability of financial resources such as liquid assets (funds- bank statements), lines of credit, and other financial means (fixed and real assets not considered here).
- Experience:** the bidder must provide evidence of participating as a main supplier in at least one (1) contract within the last five (5) years, similar to the proposed supply.

d. **Delivery:** The Goods covered by this bidding process are required to be delivered in accordance with, and completed within, the Delivery and Completion Schedule specified in the bidding document. Section 2, Schedule of Supply delivery.

4. Bidding will be in accordance with the National Competitive Bidding procedures as specified in HFO procurement manual and is open to all eligible bidders

6. A complete set of bidding documents in English may be obtained by interested eligible bidders upon a written application to the address below. The document may be collected or sent by airmail for overseas and surface mail or courier for local delivery. In case of urgency email delivery may be used for overseas.
7. Bids must be delivered to the address below **on or before 19th August 2019 at 5.00 hours**. Electronic bidding **will not be permitted**. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on **19th August 2019** at 17.00 Hours.
8. Bids shall be valid for a bid period of **60 days** after Bid Opening. Bids with less validity period will be rejected.
