Job Advert for position of Torit Program Coordinator (1 Volunteer)

Women Relief Aid (WRA) is an independent women-led National NGO founded by group of young South Sudanese ladies to provide immediate supports to vulnerable women and children of war zone of South Sudan. WRA has been registered in 2021 with registration No. 4076 with the aim of providing immediate hope to women/children in the war zone of South Sudan through carrying out advocacy and training programs on SRHR, gender justice, women empowerment programs, women's education, strengthening the public understanding on women's sexual rights, and the relationship among sexuality, development and social justice. Consequently, the organization's focus is not kept limited either in terms of geography or sector. Whilst operating in different states of the country, WRA carry a range of interventions in the areas of women rights, education, health & hygiene, women empowerment, emergency response & preparedness, governance, free legal aid, human rights, etc.

The type of activities we undertake range from capacity building to service delivery, with focus remaining on the deprived and marginalized segments of the women and girls in the Society. Whereas in terms of operations what characterizes WRO's functioning are its efforts to (a) enlist involvement of the locals when initiating activities at the grass root level; and (b) mobilize women for bringing peace, tolerance, and development in society.

WRA is looking for suitable qualified South Sudanese lady age bracket 20-27 years currently living in Torit Town at the moment to fill this urgent position.

Roles and Responsibilities

- 1) To coordinate all the activities of WRA in Torit and Eastern Equatoria State.
- 2) To conduct one day dialogue with health authorities to Create teenage-friendly dedicated services at PHUs that can work on the weekend to cover Hospitals along the continuum of care, from pre-pregnancy to antenatal visits, to birth and post-natal visits;
- 3) Design and implement community and family-based approaches to address adolescents SRH needs and issue through Identification and training of 40 mentor mothers to reach and assist adolescents living in the hardest-to-reach areas in seminomadic groups through used.
- 4) Identify and train 80 adolescent peer- educators and counsellors for adolescent counselling on sexual and reproductive health issues at health facilities and in the communities.
- 5) Carrying out adolescent SRHR media campaigns awareness to end early marriage and pregnancies (conducting 6 radio talk show).

- 6) Forming 8 girls' groups/clubs, carrying out debates in school, peer discussions, at 8 schools with a total population of 4,000.
- 7) Increasing awareness of young women's human rights in the project area.
- 8) Increasing knowledge and skills to 2,500 adolescents aged 10-24 about their sexual, reproductive health and rights.
- 9) Increasing parent and child sexual reproductive health and rights communication targeted 3,500 parents.

Qualifications/ Requirements

- 1. This position is open to South Sudanese lady age bracket 20 to 27 years.
- 2. She must have good reporting skills with knowledge of command of good essay writing skills.
- 3. Fluent in English to communicate to different stakeholders at local, national and international level.
- 4. She must be of good characters especially from religious background (born again Christian).
- 5. At least one year of working experiences in the field of SRHR, GBV, etc.
- 6. She must have diploma as a minimum level of education in the field of social sciences (Nursing, Clinical doctor etc.).
