COUNTRY PROGRAM OVERVIEW

The overall objective of the ALIGHT South Sudan program is to assist the South Sudanese to respond and react to community needs. To achieve this objective, ALIGHT implements a multi-sectoral program that includes Water and Sanitation, Nutrition, Gender based violence prevention, Livelihood, Child Protection and response activities. ALIGHTs is expanding its outreach mechanisms and introducing innovative new initiatives. ALIGHT currently has program activities in Aweil, Kapoeta South, Ulang, Budi and Kajo-Keji Counties.

I. Main objective:

The Protection Officer is responsible for the implementation, monitoring and evaluation of all protection project activities in Aweil Centre to ensure quality outputs and outcomes. S/He regularly collects quantitative and qualitative data on project activities and identifies areas of improvements. S/He support the Senior Protection Officer to represent Alight in the field locations in absence of the Senior Protection Officer and creates cooperative and positive relationships with local stakeholders, such as local authorities, other NGOs and communities.

Responsibilities/duties:

- Supervise and provide guidance to Social Workers, Case workers and volunteers and GBV staff ensure integration of activities.
- Undertake training on PSS, Case management (GBV and CP) and establishment of CP help desk in selected schools
- Work with other protection partners to maintain and regularly update service mapping information for service referrals
- Ensure that ALIGHT has useful, valid and reliable information on the situation of children in the project locations
- Conduct surveys and assessments in communities and schools
- Implement participatory monitoring tools such as focus group discussions, community mapping and the collection of most significant change stories

- Elaborate and manage monthly planning of project activities and report to the Senior Protection Officer
- Ensure a proper implementation of project activities by defining roles, operating processes and working methodologies for the national staff in project locations
- Monitor all activities related to the construction/rehabilitation of child friendly spaces, child protection help desks, temporary learning spaces, latrines and hand washing facilities
- Be a focal person for the CPIMS reporting and ensure data security protocol are in place I and followed at all times
- Coordinate Family Tracing and Reunification services for unaccompanied and separated minors and their placement to temporary foster care and ensure continuous monitoring
- Ensure quality recreational activities in Child Friendly Spaces and psycho-social support for vulnerable children through Child Protection Help Desks Spaces and ensure follow-ups and monitoring of each case
- Oversee the distribution of materials to vulnerable children, school children and foster families
- Prepare detailed internal reports with findings from the field and recommendations in a timely manner
- Organize and facilitate trainings and awareness campaigns foreseen by the project following the guidelines by the Senior Protection Officer (in the areas of Child Protection, Children's rights, FTR, Alternative Care Systems, Case Management, Psychosocial Support, GBV)
- Contribute to the identification of new opportunities for child protection projects in the area
- · Document case studies, best practices and lesson learnt from activities implemented
- · Any other tasks assigned by the Senior Protection Officer or Protection Coordinator
