1.0 Background:

Stromme Foundation (SF) seeks to recruit a South Sudanese national for the position of Monitoring Evaluation and Learning Assistant based at Juba office. SF is a Norwegian Non-Governmental Organisation (NGO) which provides humanitarian development assistance to needy communities in the third world countries for greater equality and quality of life with dignity. SF does not directly implement such development activities but collaborates with and enables local/national registered NGOs to carry out such activities. JOB PURPOSE

The purpose of the post of the Monitoring Evaluation and Learning Assistant - TOFI South Sudan is to support the TOFI program officers for Inclusive Education and Inclusive Economic Empowerment in South Sudan to fulfil the routine Reporting obligations in accordance with the TOFI Monitoring, Evaluation and Learning system.

Basic Responsibilities

- 1) Update the TOFI online reporting system with activity reports from the fourth quarter of 2021 to date.
- 2) Support the implementing staff Compile reports of ongoing activities using the standard TOFI reporting templates and upload them on the TOFI online MEL system.
- 3) To conduct some Inclusive Education and Economic Empowerment Trainings to partners and beneficiaries of ToFI
- 4) Provide support and guidance to partners in areas of data collection, management, reporting and utilization for program improvement.
- 5) Support the documentation of at least 6 Success stories using standard TOFI templates.
- 6) Conduct regular data validation through routine data quality checks to TOFI implementing

Personal specifications
