Job Title: Project Manager - GCF Design

#### **ROLE PURPOSE:**

SCI South Sudan requires the services of a highly qualified individual to project manage the development of the Climate and Education Project (henceforth 'BRACE') design team and manage the proposal development. The applicant is required to have strong experience in project management and business development including excellent skills in coordinating multiple teams and inputs, project and time management, budget management, communication management, high attention to detail and quality, and knowledge of donor requirements.

The Project Manager will be line managed by the SCI Head of Business Development and will sit in the SCI South Sudan PDQ team. The Project Manager will manage a Project Coordinator, have a dotted line to the different Technical Leads. additional consultants for specific assessments and analysis, and will coordinate inputs from the SCI South Sudan technical team and member staff (Save the Children UK and Australia).

- Work closely with the technical lead to ensure a unified vision and understanding of the project proposal.
- Provide administrative management for the consultancy team including the Technical Lead.
- Support with procurement and management of additional consultants, including developing Terms of Reference with SCI South Sudan and Aus; supporting supply chain and procurement processes; task management; and leading meetings.
- Act as SCI South Sudan focal point for administrative GCF design-related processes, coordinating SCN and SC Australia technical reviews and approvals as required.
- Support development of SCI South Sudan's relationship with key government and partner stakeholders, planning and facilitating workshops and meetings as required. SCI South Sudan's Senior Technical Advisors and the Technical Lead will lead technical discussions.
- Work with the South Sudan Country Office and SCN in managing and monitoring design funding from GPE
- Oversee and manage consultant(s) delivery of activities, including:
  - Feasibility study

  - Economic and financial analysis
