BACKGROUND/INTRODUCTION

Islamic Relief is an independent humanitarian and development UK based organization, with an active presence in over 40 Countries across the globe, we strive to make the world a better and fairer place for people still living in poverty. Islamic relief began its humanitarian operation in South Sudan in 2004 focusing on providing lifesaving aid and implementing developmental Programmes to support people affected by flood, drought and Conflict establishing three sub offices in Narus (Kapoeta East), Wau, Warrap. A satellite office in Yei and Main office in Juba.

INTRODUCTION

With funding from IR USA, IRSS is currently implementing project “Early Recovery and Resilience Program for Communities affected by conflict in South Sudan (ERRP)”.

In order to realize this, Islamic relief intends to procure 400 goats both local indigenous and hybrid breeds to be distributed to targets of 200HH in both Kapoeta and Wau. Indigenous Toposa and Nilotic breeds (200 does) and boar hybrid breed (200 bucks) to be distributed to 200 vulnerable households to yield high quality of meat and milk. These breed have the following characteristics; prolific nature enable it to survive in harsh climatic condition and its long search for pasture and water and can be suitable for cross breeding purposes with the aim to build resistant breed to harsh climatic condition with ability to survivability Compared to the imported hybrid of goat which are opposed to harsh climatic condition which affects their adoptability to the varying ecological zones of South Sudan where it is to be raised. With the above analysis, the implementation team in Wau and Kapoeta East have resolved to procure the

Nilotic breed for Wau, and indigenous Toposa breed (doe) and boar hybrid breed (buck) to cross breed and produced adoptable dual-purpose breed.

The Overall Goal: The objective of this project is to strengthen poor households' livelihoods and resilience in Wau and Kapoeta East County.

Terms of Reference:

- Toposa and Nilotic (Indigenous local breed) are preferred because of its prolific nature i.e tolerance to harsh climatic condition, pasture and water and its ability to produce milk for human consumption.
- Boars 75% pure (dual-purpose hybrid breed) are preferred because of their hardiness and their tolerance to all climate (hot or cool) and will be subjected to cross breeding with the local breeds.
- Does and bucks should be at age of puberty and age at first conception/Parturition are preferred because of their ability to cope up with changing environment and good indicator of sexual maturity.
- The Goats should be healthy, i.e. actively eating, with good vision, hearing and breathing and free from zoonotic diseases. There should be no major physical injuries and no limping.
- Feed continuously, friendly and scavenge well with normal body shape
- The supply has to procure the Toposa breed within the kapoeta region to determine the breeds while Nilotic breed has to be procured within Wau region.
- The buck (200) improved breed of boar hybrid breed buck to cross will be procured from the neighboring region with special focus to the Uganda, Kenya and Sudan in order to enhance genetic make-up and to improve hybrid vigor (breed complementarity)
- The County Veterinarian Officer shall certify and issue a bill of health for the Goats purchased.
- The supplier will procure and distribute the above agricultural inputs to the beneficiaries designated locations or distribution points with as follows:
 - In Wau, western Bah el Ghazel state, the two Payam where Islamic relief South Sudan is carrying the FSL intervention activities include Bazzia and Baggari Payam. In Bazzia, Payam, the transportation of the goats will reach to four Boma (villages) Gattan, Taban, Gedi, and Akuyo, with the furthest distance being around 50 to 60 kilometer, in Baggari Payam, Baggari and Biringi around 15-20 Km all from Wau County head equators. The above location has 25 households targeted for the goat breed distribution to vulnerable house Hold each receiving a pair of goat breeds totaling to 50 goats per location
 - While in Kapoeta East, Eastern Equatoria state, the FSL intervention is carried out in Narus payam and targeting Lopua boma (villages) with transportation to lopua around 15 - 17 Km from Narus center with a pair of goat distribution to total number of vulnerable house to 50 households.
