#### Background.

CAO is a National Non-Governmental, non-political, and not-for-profit organization to address humanitarian needs, transition, and development assistance. Our mandate is to build capacities of South Sudanese communities through socio-economic development, peacebuilding, access to justice, promotion of human rights, good governance, formal and non-formal education, nutrition, WASH program, health services, poverty alleviation to through initiatives such as agricultural capacity building programs and promotion of cultural tolerance.

CAO was established in 2014 with over 8 years of operations in Jonglei, Upper Nile, Central Equatoria and Warrap States of South Sudan with field offices in Ayod, Fangak, Akobo, Pigi/Canal, and Uror in Jonglei State and Nassir and Ulang in Upper Nile and Twic in Warrap state with a head office in Juba. Over 100 people, a mixture of South Sudanese and foreigners are employed by CAO South Sudan.

Through funding from SSHF and World Bank, CAO is implementing intergrated lifesaving and a general health service provision in the Counties of Canal/Pigi, Ayod and



Fangak. It is in light of this that CAO would like to recruit a competent South Sudanese candidate for the above position.

#### JOB SUMMARY

The Water, Sanitation & Hygiene (WASH) Manager is responsible for running and supervising water, sanitation and hygiene programs at all stages of the project management cycle. He/she is also responsible for accomplishing the program objectives and outcomes within the contextual constraints. The manager ensures the overall success of the program by making the wash team completes the defined activities while adhering to internal standards and contractual obligations; write proposals and initiate and effectively manage and report on projects in line with the objectives, timeframe and budget.

Further objectives for the WASH Manager concern the capacity building, management and mentoring of staff; humanitarian needs identification through monitoring of the evolving situation; context analysis to contribute to the development of future programs; Assess WASH needs, design projects, Provide technical support, leadership and strategic direction; meet quality standards in WASH delivery, encourage beneficiary participation, liaise with other stakeholders and a strong link to CAO Health and Nutrition.

This position will report to the Executive Director, and will be based in Juba, with extensive travel to field sites.

- Rapidly adapt, design and overall response to the changing context, taking into account the needs of affected communities, current level and capacity of actors, and CAO's growth and expansion strategy.
- Manage the assigned WASH project(s) to meet the project objectives within budget, set time frame, quality, and standards.
- Provide strong leadership of the assigned WASH project(s), working to ensure both short / long-term positive impacts and outcomes for the beneficiaries, local authorities (where applicable) and local WASH staff.
- Develop and implement an appropriate and effective WASH strategy, setting clear objectives and indicators, for WASH activities in consultation with other WASH staff and field managers, and, where appropriate, with the local communities.
- Continuously monitor and supervise WASH activities, overseeing the technical design, execution and evaluation of progress through outputs and impacts using both quantitative and qualitative data.
- Provide input into the integration of beneficiary participation and accountability in all aspects of the project.
