- Strong written and verbal communication skills in English
- Quality control job is highly recommended
- The consultant should have all valid travelling documents
- The Latrine **MUST** be Gender Segregated and Disability Friendly.
- The contractor after signing the contract should prepare immediately all the recommended construction materials as per the BoQ for dispatch. Therefore, any delay which is not genuine or related to force majeure may result to penalty or considering the next bidder regardless of price.
- The Contractor is responsible for his or her Accomodation, feeding, transportation and other related travelling cost.
- Payment of 100% shall be done after work completion through Bank transfer or Cheque.
