Catholic Relief Services (CRS) South Sudan is seeking for international consultancy firm to provide a team of experienced consultants to conduct qualitative evaluations of its Building a Culture of Social Cohesion and Peace (BCSCP) Project in South Sudan.

Catholic Relief Services (CRS) seeks to contract a third-party consultancy service provider to undertake the final project evaluation of the Building a Culture of Social Cohesion and Peace (BCSCP) in South Sudan. The program is funded under European Union's (EU) Instrument Contributing to Stability and Peace (IcSP) and implemented by Catholic Relief Services (CRS) in Jonglei state and Greater Pibor Administrative Area (GPAA) in South Sudan.

To be eligible for consideration, interested consultancy firms must meet the following requirements.

- At least five years experience in conducting program / project evaluations as sole evaluator or team leader in development cooperation and/or humanitarian aid
- Post graduate qualification in program evaluation or a related field.
- Prior work experience in South Sudan and/or other contexts of conflict or post-conflict recovery is highly desirable.
- Good understanding of project cycle management
- Proven record of accomplishment of producing clear written analysis and recommendations for further development of programme
- Deep understanding of current topics in development policy and cross-cutting issues
- Proven experience with research methods (including quantitative, qualitative, and participatory), information analysis and report writing
- Fluency in spoken and written English.
- Cultural sensitivity and inter-cultural communication skills.
