APPENDIX 1
INSTRUCTIONS FOR THE PREPARATION AND SUBMISSION OF QUOTATIONS

1. Signature and Stamping of the Quotation

Your quotation must be signed and stamped by an official legally authorized to enter into contracts on behalf of your company/organization.

2. Total Price and Unit Prices

You should quote **your best, firm and fixed total price and unit prices** in US Dollars.

3. Evaluation Procedure. Acceptance of Quotations

Your quotation and the others which are submitted in response to this RFQ will be reviewed and evaluated by VOSDO in a fair and impartial way in accordance with the provisions of the VOSDO Financial Rules and Procurement Procedures. The best quotation submitted (**lowest, technically acceptable**), all factors considered (**Best Value for Money, Fairness, Integrity, and Transparency Effective Competition, the Best Interest of VOSDO**), price alone being not determinative, will receive the award.

4. No commitment

This RFQ does not commit VOSDO to award a contract. VOSDO reserves the right to accept or reject any quotation(s), or annul this RFQ and reject all quotations, at any time prior to award of contract, without thereby incurring any liability to the affected invitee(s) or any obligation to inform the affected invitee(s) of the grounds for VOSDO's action. VOSDO also reserves the right to negotiate and award only a portion of the requirement; to negotiate and award separate or multiple contracts for the elements covered by this RFQ in any combination it may deem appropriate, in its sole discretion. This RFQ contains no contractual offer of any kind; any quotation submitted will be regarded as an offer by the invitee and not as an acceptance by the invitee of any offer by VOSDO. No contractual relationship will exist except pursuant to a written contract document signed by the authorized official of VOSDO and by the successful invitee(s) chosen by VOSDO.

5. Payment

The normal terms of payment by VOSDO are 30 days upon satisfactory delivery of goods or performance of services and acceptance thereof by VOSDO, progress payments being allowed upon agreement of the Parties.

- h. Only offers from companies with bank accounts in the name of the company can be accepted.
- i. Items should be packaged to provide adequate protection during rough handling in-transit. All items should be marked clearly with the line item number and Purchase Order number.
