Terms of Reference

1. Background Information

Consortium of five organizations namely Light for the World, ZOA Dorcas, VNG, The Hague Academy for Local Governance and Africa Disability Forum (ADF) in South Sudan with funding from the Ministry of Foreign Affairs in Government of Netherlands.
