Key Tasks and Responsibilities:

Under the direct supervision of the Traffic Manager the incumbent shall perform the following duties:

- Perform a daily inspection of the vehicle and trailer and ensure that they are mechanically sound and to report any problems or defects to immediate supervisor.
- Carry responsibility for truck allocated and cargo and provide assistance and guidance to those vehicles under the convoy.
- Responsible for telecommunications and usage of GPS, HF & VHF radio & communications to inform Traffic Manager of progress and position on an hourly basis.
