**CONSULTANTS TERMS OF REFERENCE

Introduction

Coalition for Humanity was funded by SSHF to provide general protection and HLP services to IDPs in Bentiu/Rubkona Mangala and Juba former POCs, conduct protection assessments, monitoring, GBV risk analysis, and provide Housing Land and Property (HLP) redress mechanisms to affected populations. The aim of the HLP/Protection component is to prevent and mitigate protection risks through enhanced preparedness and resilience, enhance protection assessment and monitoring to inform protection and overall humanitarian response and ensure the provision of critical protection related assistance and specialized services through an integrated approach to address the priority needs of targeted people among vulnerable women, men, girls and boys in hard-to-reach areas and the project objectives were.

1. Protection monitoring, assessments and analysis of protection and human rights violations to inform response and advocacy.
2. Community awareness through outreach activities, particularly on HLP issues for IDPS intending to return to original homes including providing women and other vulnerable members with pro bono lawyers to support/provide legal services as required.
3. HLP programming in terms of supporting women, boys, men and girls through pro bono legal services and advice.
4. Strengthening community-based structures and networks through outreach activities, training and building capacity of local leaders to enhance and tackle GBV issues and other protection concerns.
5. Coalition of Humanity will build the capacity of block leaders, and representatives of men, women and youth to maintain sanitation in POCs by sharing latrine cleaning responsibilities and managing garbage collection as an exit strategy and means of ensuring project sustainability.

Purpose,

Conduct awareness raising in the community targeting 12,000 people to sensitize community on the available redress mechanisms and actions they can take on critical protection concerns, rights violations protection risks, referral pathways, redress mechanisms, and how to enhanced resilience in the community. Coalition for Humanity intends to reach people throw radio talk shows and community Public Address System.

Scope of Work

As a consultant you will be expected to do the following.

1. Conduct interviews with key stakeholders like local authority, women, girls, gender and protection officers. The interviews will focus on protection and HLP concerns and solutions in the community.
2. Record both video and audio clips of the interviews and other awareness activities.
3. Edit video and audio clips to produce pre-recorded protection sensitization messages that can be used in public address system.
4. Transcribe the audio and video clips, put sub titles in English language for clips recorded in local language.
5. Support the field team in awareness raising activities through public address system.
6. Prepare a final activity report on awareness raising

Deliverable

1. Conduct interviews Schedules for leaders' women in IDP camps
2. Recorded both video and audio clips for of the interviews and other awareness activities.
3. Pre-recorded protection sensitization messages that can be used in public address system.
4. Transcribed the audio and video clips with sub titles in English language for clips recorded in local language.
5. Final activity report on awareness raising
