ABOUT BBC MEDIA ACTION:

BACKGROUND OF THE PROJECT:

Funded by the UK's Foreign, Commonwealth and Development Office (FCDO), the Girls Education South Sudan (GESS) phase2 programme is a five-year initiative running from May 2019 to March 2024. The programme is implemented by Mott MacDonald as the lead agency and supported by BBC Media Action, Windle Trust International, Montrose, and Leonard Cheshire as consortium partners. The ultimate intended impact of the GESS phase2 programme is 'transforming the life chances of a generation of South Sudanese children (particularly but not exclusively girls) through education, whilst stabilising priority areas of the education sector and concurrently seeking to deliver improved quality education'.

BBC Media Action is implementing the Behaviour Change Communication (BCC) - component of GESS. This component contributes to GESS's intended impact by supporting the key programme outcomes of building further gains in school enrolment, improving girls' and children with disabilities educational attainment, reducing barriers to education, and promoting equity in access of education for all children. To achieve these, BBC Media Action uses the radio programme 'Our School', Public Services Announcements (PSAs) and



community outreach activities to raise awareness, to address the negative social cultural barriers which hinder girls and children with disabilities from accessing an education.

As part of the PSA production, BBC Media Action is seeking for a qualified female or male freelancer, under the following objectives:

OVERALL OBJECTIVES OF THE JOB:

To produce 2 topics of PSAS in 10 languages with key messages on Girls' education objectives that links to BBC Media Action's Social Behaviour Change Communication Output - Our School. The key messages will be on:

Cash transfers' Accountability / managing public funds and resources for effective service delivery.

Sustainable ways to support girls and children with disabilities to continue with school and develop their local schools when GESS project ends.

The PSAs will then broadcast on 24 local radio stations.

1. Deliverables of the producer

The Producer/s to produce 2 topics of Radio PSAs that relate to GESS objectives, each in 10 languages (Local Arabic, Toposa, Lotukho, Dinka, Nuer, Shilluk, Zande, Bari, Murle and English).

The producer/s to develop creative ideas of how the PSAs will be relayed to the audience by developing a PSA creative brief, Script and share with the Senior production manager and Project manager.

The producer/s will supervise the freelance translators by sending them scripts to translate and give them directives on what is needed from them.

The producer/s will organise actors for PSA recording, rehearse and record the approved translated PSA scripts, with support from language translators.

The producer/s will edit and mixdown the recorded PSA into a final product and organise a translator to listen back for correct language. The producer/s will share the final product with the project management for comments and amend when there are corrections needed.

2. Other tasks

The PSA freelance producer will be expected to work in close collaboration with the Senior Production manager and Project manager for accurate and easy execution of the task.

3. Assignment Duration, Location and Work Plan.

This assignment is expected to take place in Juba, at BBC Media Action office and it should be completed within 14 working days from the 21^{th} July -3^{rd} Aug 2023 - as per the below tentative schedule:



- 21th July 2023: Sign contract, receive briefing on the PSA-GESS Objectives. Develop
 the PSA creative brief for review and approval to proceed.
- 24th July 2023: Script the 1st draft of the PSA and submit for review. Begin to plan and
 organise translators and actors to work with by sending freelance contracts for
 signing.
- **25**th **July 2023:** Receive and send reviewed script to the translators for translation and organise actors for recording.
- 26th and 26th July 2023: Record PSA scripts
- 27th 31st July 2023: Edit and mix all the recorded PSAs.
- 1st Aug 2023: Submit edited PSAs to management for review and feedback.
- 2nd 3rd Aug 2023: Check with translators for correct language and submit final produced PSAs and concluding the contract and payment of dues.

4. Expectations.

The PSA Freelance Producer will be required based on the contents of this TOR to present his/her interpretation of the tasks and programme scripting as well as the workplan for the PSA production to finish.

PERSON SPECIFICATION - REQUIRED KNOWLEDGE, SKILLS AND EXPERIENCE

- Degree/Diploma in Mass communication
- Working experience of not less than 3 years in Radio Programme production including PSAs with track record of working as radio station practitioners in the abovementioned required areas.
- The individual being contracted should be able to demonstrate their expertise and practical approach used over the years in carrying out practical radio PSA production.

COMPETENCIES:
