### **SUMMARY OF POSITION:**

#### **PURPOSE:**

The project targets to develop innovative acute malnutrition prediction models in humanitarian contexts in South Sudan, and sensitize and empower humanitarian stakeholders to use predictive analytics for acute malnutrition in key decision-making to anticipate and respond effectively to acute malnutrition. The Job purpose is therefore to provide advanced data analysis support to the Enabling Anticipatory Action for Acute Malnutrition in Practice through strengthening the early warning systems Project (MERIAM 2) project in Gogrial West County.

#### **I. ESSENTIAL JOB FUNCTIONS**

##### **Overall key responsibilities**

- Support mapping of existing Early warning system including seasonal assessment using IPC analysis, routine surveys, national data systems (HMIS), diseases surveillance systems etc
- Engage regularly in sub-national coordination groups and conversations, including with both humanitarian, development, and government stakeholders, on predictive analytics, early warning systems, anticipatory action, and nutrition interventions.
- Help university partners in customizing and contextualizing models, collecting needs and feedback from stakeholders, testing impact in decision-making, evaluating effects on operational frameworks, reporting to university partners for learning, and producing knowledge products (case studies, lesson learned, blogs, articles).
- Pilot the predictive models during an ongoing exercise such as seasonal assessments like the long rains assessments, short rains assessments, and IPC analysis.
- Engage in Technical handbook and user's guide preparation



- Provide technical support to all projects in advanced data analysis and visualization
- Undertake other tasks assigned by the research coordinator or the Field Coordinator

### Reporting

- Ensure qualitative and timely reporting of all project activities within donor stipulated timelines
- Ensure follow up of any deviation from targets before the reporting and explained in the monthly reporting
- Be available for responses to any donor questions and queries to see to their final resolution.
- Provide mentoring to project staff on proper reporting protocols.

### SUPERVISORY RESPONSIBILITIES

- Direct line management of the data manager

### FISCAL RESPONSIBILITY

- Monitors the budget on an ongoing basis comparing the forecasts closely with the expenditures. Ensures deviation to spending is flagged and solutions sought timely
- Collaborates with the finance manager (Juba and field level) to produce monthly budget follow-ups for effective budget management.
- Responds to queries from donors within the stipulated timelines.
- Ensures development and operationalization of all program work plans

### PHYSICAL DEMANDS
