1. Background; Catholic Agency for Overseas Development (CAFOD) is the official aid

and development agency of Catholic Churches in England and Wales. Trocaire is the official aid and development agency of Catholic Churches in Ireland. In April 2015, CAFOD South Sudan merged with its Irish sister agency, Trocaire South Sudan, integrating their programmes under CAFOD and Trocaire in Partnership (CTP). This merger allowed for pooling of knowledge and resources, reducing programmatic overlap and overhead costs. As members of the Caritas network, CTP champions localisation and works exclusively through partnership with church and non-church national organisations. CTP provide funding as well as ongoing technical support, capacity building and accompaniment to partners, to ensure sustainable delivery of programmes as well as adherence to quality standards.

CAFOD remains the lead agency, maintaining its programmatic approach, as well as its financial and administrative systems and procedures.

CTP through its partnership and localisation Lense takes a multisector integrated approach to programming. RFQ Instructions; The CAFOD in South Sudan hereinafter referred to as "procuring entity" intends to contract a Supplier to Supply and Delivery of Fodder Preservation and Processing Equipment i.e. 12 Hay Balers (Hay Balers of Hay Bale capacity of 30 40 Kgs per bundle), 6 Chaff Cutters for Silage making and 360 Kgs of Napier grass cuttings i.e preferably made using wooden materials or metallic fabrication . The RFQ is open to eligible Supplier who meet key requirements as indicated in the instructions.
- 6. Language of RFQ; All the information for RFQ process shall be provided in English language.
- **7. Experience**; Prospective Suppliers must have carried out successful Provision of Climate Risk Assessment for similar services to INGOs and UN Agencies.



- 8. Terms and Conditions; Eligible and interested Suppliers shall be required to read and be willing to abide by CAFOD procurement terms and conditions, CAFOD Supplier Code of Conduct, CAFOD Safeguarding policy, and CAFOD Antibribery Policy as indicated in Appendix Schedule 19.
- **9.** Eligible Suppliers; The procuring entity's employees and their relative (spouse and children) are not eligible to participate in the RFQ process.
- 10. - 13. Notification of Successful and Unsuccessful Suppliers; CAFOD will only notified the successful bidder/Supplier for the RFQ for Supply and Delivery of Fodder Preservation and Processing Equipment i.e. 12 Hay Balers (Hay Balers of Hay Bale capacity of 30 40 Kgs per bundle), 6 Chaff Cutters for Silage making and 360 Kgs of Napier grass cuttings i.e preferably made using wooden materials or metallic fabrication outcome in writing, and this will be done after three (3) weeks to closure of RFQ deadline.

14. RFQ Guidelines/Regulations and Criteria

- **14.1Incomplete Application;** The application forms which are not filled and duly stamped and submitted in the prescribed manner will not be considered by the reviewing committee mandate to carry out this exercise.
- **14.2The RFQ Data;** It is understood and agreed that the RFQ data of the prospective Supplier is to be used by CAFOD in selection of prospective Supplier to perform the contract in respect items as described by the client in **Appendix Schedule 19** in this document.
- **14.3RFQ Requirements;** Prospective Suppliers will not be considered qualified unless in the judgment of CAFOD they possess the capability, experience, qualified personnel, available and sustainable



equipment, and net current assets or working capital enough to satisfactorily execute the contract for goods.

15. Essential Criteria for RFQ

- **15.1Experience;** The prospective bidder shall have at least seven (7) years' experience in the provision of similar services. Past performance will be shown by way of attaching relevant local purchase order (LPO)/contract agreement, and letters of recommendations. Suppliers should further specify the area of specializations. Prospective suppliers should have special experience and capability to organize, supply and deliver assignment as per agreed timeliness in the contract agreement.
- **15.2Financial Condition;** The supplier's financial condition will be determined by latest bank statement statements submitted with the RFQ documents as well as latest bank statement for the last six (6) months.
- **15.3Declaration;** Application MUST include a declaration **Appendix 16** certifying the accuracy of the information given.
- **15.4Withdrawal of RFQ;** CAFOD has the right to reject the RFQ from a selected firm, should a condition arise between the time the firm has bidder and the bid opening date which in the opinion of the CAFOD could compromise the performance and but not limited to bankruptcy, change in ownership or new commitment.
- 16. **Declaration;** (Failure to provide this information shall lead to disqualification from the exercise). Having studied the RFQ information for the above Invitation for RFQ we/I hereby state:
