Food Security Through Agribusiness Development Program Outcome harvesting 2022

ORGANIZATION BACKGROUND:


Stitching CORDAID is an international NGO registered in the Netherlands with over a century-long history of emergency and development aid in several countries, including South Sudan. The organization is implementing programs on resilience and livelihoods, agriculture and food security, emergency response and recovery, health, and Peace and Justice in South Sudan. The experience and knowledge gained in the target counties have been used for the development of this project (SSADP II).

PROJECT BACKGROUND:

The Food Security Through Agribusiness in South Sudan Project (SSADP II) is a five-year project that runs from late 2018 to July 2023 funded by the Embassy of the Kingdom of the Netherlands (EKN) in South Sudan. The overall goal of the project is to improve food security, income, and employment of 10,000 farmer households in selected Counties, based on the Making Markets Work for the Poor (M4P) approach and aims at enhancing food security, purchasing power, and employment position of vulnerable population in Yambio, Torit and Bor Counties. It supports the strengthening of market functions and market players to make the local markets more inclusive and more enabling for agribusiness to thrive. Moreover, the project strives to increase farmers' and agribusiness' (MSMEs, Cooperative, VSLA) access to the organization, technology, markets, and finance.

This project is being implemented by the following international organizations; Cordaid, Agriterra, and SPARK. Cordaid is the lead agency, and it works closely with the relevant line ministries of the Government of South Sudan, and key stakeholders, including local and international NGOs, UN agencies, and the private sector. Through this project, 10,000 farmers will directly benefit from

increased production and productivity through Farmers Economy and Market Association (FEMA), 1000 youths & women and 750 MSMEs will benefit from Business Development Services, 230 Farmers Cooperatives, and 120 Village Market and Social Economy, Association (VEMSA) will directly benefit from Cooperative Development and VEMSA Development Support. Also, the project will creating access to finance in partnership with Rural Finance Institute (RUFI) in a Revolving Loan Fund (RLF) scheme for agribusiness development in the project target counties. The selected value chain includes Maize, Sorghum, Cassava, and Groundnuts. conceptual model of the project is shown in the diagram above.



Project Outcomes

- 1. Improved inclusive agri-business market functioning
- 2. Enhanced sustainable production and productivity



- 3. Improved performance of cooperatives and Agri-MSMEs and new jobs are created
- 4. Farmers and Agri-businesses more resilient to shocks and hazards both natural and conflict related.

THE ASSIGNEMENT

Cordaid South Sudan would like to hire a consultancy firm or an individual consultant to carry out "Outcome Harvesting" for its "Food Security through Agribusiness project in South Sudan". This assignment is meant to capture both intended and unintended outcomes of the project interventions, which is being implemented in an environment where multiple factors are at play. Critically, the assessment is intended to generate outcome data to inform project performance to foster cross learning across the entire project

GENERAL PURPOSE FOR THE OUTCOME HARVESTING

The purpose of this Outcome Harvesting is expected to inform the project management team on the level at which the project is achieving its medium- and long-term results (outcomes). It will also support learning about those achievements and failures. (Exactly!

SPECIFIC OBJECTIVES OF THE ASSIGNMENT

The following will be the specific objectives to be pursued by the consultant

- Take a suitable sample to assess performance/ achievement of the outcome indicators
- To measure the levels of targeted intended and unintended outcome achievements
- Measure the project intervention contributions to the outcomes.
- Document lesson learnt and provide appropriate recommendations.

Location for the assignment.

The study will be conducted in Torit, Bor and Yambio County. The beneficiaries list will be shared with the consultant.

SCOPE OF WORK/TASK

The consultant firm/individual scope of work will include:

- Develop an Outcome Harvesting approach which is customized to the specific needs of the project.
- Design and propose the Outcome Harvesting methodology and tools that will be agreed upon prior to data collection.
- Review all relevant project documents i.e., project reports, study reports and databases necessary to complete the report.
- Document change agents/influencers such as those who; inspired and encouraged change, facilitated change, and supported any change. The consultant will also engage with informants within the project implementers in formulating outcome descriptions
- Review final documented outcomes and select those viable for verification and validation, to increase the accuracy and credibility of the findings.
- The harvester will also obtain the views of a few individuals who are independent of the intervention (third party) but knowledgeable about one or more of the outcomes and the change agent's contribution.
- Analyze and interpret: the Harvester will classify all outcomes in aligning with the outcome indicators in consultation with the project informants.



- Support use of findings: Harvesters propose issues for discussion to harvest users grounded in the evidence-based answers to the harvesting questions. They facilitate discussions with users, which may include how they can make use of the findings.
- Reporting and dissemination of the findings to the stakeholders in an organized fora as deemed appropriate

SPECIFIC QUESTIONS TO BE ANSWERED BY THE OUTCOME HARVESTING CONSULTANT

The outcome harvesting is expected to shed light on the following questions about observed project outcomes which can attributed to the project interventions or other factors.

- 1. What were the anticipated and/or unanticipated outcomes?
- 2. How were the outcomes achieved?
- 3. Did the intervention(s) and/or other factors contribute to the outcomes?
- 4. How can the findings of the outcomes harvesting inform future programming decisions?

KEY RESULTS OF THE ASSIGNMENT

The results of the assignment will include.

Inception report: the detailed description of the methodology

- Data collection tools developed in consultation with project implementation Team.
- Present survey findings for validation
- Submit comprehensive report to Cordaid South Sudan
- Submit all data sets to Cordaid South Sudan

Cordaid South Sudan will provide the following facilitation to enable successful completion of the assignment.

DURATION OF THE ASSIGNMENT

Considering the diverse spread of the geographical areas of the project locations of Bor, Torit and Yambio, the outcome harvesting will take? at most 21 days from the date of its commencement. The consultant will be required to travel to all the field locations of Bor, Torit and Yambio for data



collection. Therefore, based on an agreed methodology, the consultant will develop a comprehensive workplan/timetable for the execution of the assignment as presented in the table below
