Background:

In South Sudan, the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH works on behalf of the German Federal Ministry for Economic Cooperation and Development (BMZ).

The project "Prevention of sexualized and gender-based violence in South Sudan" aims to work with several actors to address and prevent SGBV. Target group of the project are internally displaced persons, returnees and host communities in Yei and Juba County. The project works in three fields of action: It (1) creates improved access to low-threshold counseling services to promote gender equality and conflict resolution in families, (2) strengthens women groups and women-led organizations in the field of SGBV prevention and response, and (3) works in schools with teachers and students to discuss gender related norms and address awareness on SGBV.

The GIZ Coordination Office Juba is urgently seeking a qualified candidate to fill the vacant position of **Project Coordinator on SGBV** for the above-mentioned project. The position is based in Juba within GIZ's project office.

Scope of the Position:

The Project Coordinator manages the implementation and coordination of the project activities in all fields of action, in close cooperation with the Programme Director. He/she supports the strategic direction, management and evaluation of all aspects, and ensures regular exchange with project partners, intermediaries and beneficiaries. The Project Coordinator also plays a key role in liaison with local authorities and other relevant stakeholders. He/she, in consultation with the line manager, makes technical and substantive contributions to overarching issues in cooperation with commissioning parties/clients, partners & other actors and thereby support the achievement of the agreed objectives, of the respective project and provide impetus for further strategy development.

Your Tasks

- ❖ Planning, steering and implementation of activities in the project in line with the project's objective and in close cooperation with the technical advisor in the field as well as the head of component
- ❖ Provide technical advice to the implementing partners and the output indicators.
- ❖ Conceptualizing, planning and implementing the 2nd field of action, cooperation and coordination with women groups and women



- ❖ led organizations in Juba, Yei County and on local, regional and national level.
- ❖ Develop monthly operational and work plans. Steer the cooperation with local authorities and local government administrators in the partner locations.
- ❖ Build partnerships with actors, networks and organization and advise in cooperation with other thematic advisors in the field of gender and SGBV
- ❖ design, prepare and implement workshops, seminars and other events on issues related to the programs area of activity.
- ❖ formulates terms of reference and selecting and supervising third parties in the course of carrying out Programme activities, including performance evaluation
- ❖ Draw up reports and presentation documents, contributes to project reporting to commissioning party
- ❖ Representation of the project together with the line manager in close cooperation with all relevant actors active in the field and the region.
- ❖ Liaison with the *Women in Local Government Administration (WiLGA)* and provide advice to WiLGA, in close coordination with the GIZ project Rural Governance in South Sudan.

- ❖ The applicant must hold a University Degree in a relevant field, preferably in Gender Studies, Law, Political Science, Social Science or similar. A post graduate degree in gender and development studies is highly desirable
- ❖ At least 5 years of professional experience in a comparable position relating to the thematic areas of gender, SGBV and gender within South Sudan and abroad. *Please provide specific areas related to the project activities in your CV.*
- ❖ Work experience with international organizations is an asset.
- ❖ Experience in working with civil society groups, international and national NGOs working on gender related topics.
- ❖ Knowledge of local government structures in South Sudan and Gender related national and international legislations, familiarity with guidelines and industry standards for SGBV prevention and programming.
- ❖ Very good knowledge of English, and Arabic, knowledge of German is an added value.
- ❖ Excellent people skills and ability to negotiate between different stakeholder groups.
- ❖ Excellent computer skills and work knowledge of Microsoft Word, Outlook, Excel and PowerPoint.
- ❖ Previous experience in M&E, moderation and organization of workshops and meetings is an asset
- ❖ Self-drive, creativity, and problem-solving capacity are required.
