Background

Hope Restoration South Sudan (HRSS) is a National Women-led Non-Governmental Organization registered with the Ministry of Justice also registered with the Relief and Rehabilitation Commission (RRC) with Headquarters in Central Equatorial State. HRSS focuses on ending GBV and Child marriage, and the implementation of women and girls' socioeconomic empowerment by building community resilience through agriculture, WASH, health, protection as well as peacebuilding initiatives. She is a Women's Rights defender who advocates for peacebuilding in South Sudan, environmental conservation as well as against Gender-Based Violence.

HRSS is seeking to contract a consultant to provide capacity-building support to Women Civil Society Organizations (WCSOs) operating in conflict-affected areas. The consultant will focus on enhancing the WCSOs' skills and knowledge in Conflict Resolution, Peacebuilding, and Security to enable them to effectively navigate and operate within challenging environments.

Objective

The main objective of this position is for the firm/consultant to capacity-build the WCSOs on Conflict Resolutions, Peace and Security training as they implement their daily activity on Women, peace and security issues.

Secondly, the firm/consultant will develop strategic plans for the 8 WCSOs within the Resourcing change



Scope of Work

1. The consultant will train 24 participants from 8 WCSOs on Conflict Resolutions, Peace and Security training for 5 days from 8th – 12th July, 2024.
2. To support the 8 WCSOs implementing the Resourcing Change project to develop Strategic Plans

Qualifications

- The firm/ consultant should have prior experience in conflict resolution, Peace, and security
- Extensive knowledge of writing strategic plans with evidence attached
- Good knowledge of Conflict Resolution, Peace, and Security and gender mainstreaming, conflict resolution and peace-building
- Good moderation, facilitation, and training skills.
- Ability to give realistic examples of Women's Peace and Security.
- Extensive knowledge and experience in strategic plan development (*evidence to be attached in the application*)
- Ability to work independently with a minimum of supervision.

Requirements for application:

1. The firm/consultant is expected to present a detailed narrative proposal indicating the training approach and methodology.
2. The firm/consultant is expected to present an additional proposal on the plan and methodology they will use to write a strategic plan for the 8 WCSOs engaged in the program.
3. The firm/consultant is expected to accompany the narrative proposal with a detailed financial proposal including all associated costs including professional fees, travel costs, accommodation, periderm, and any other related costs.
