The health project Officer will work under the supervision of the head of Program to provide programmatic and management support for efficient implementation of the COVID-19 UN Women Response Mechanism. The health project Officer will be assigned to take responsibility for discrete tasks related to implementation of project activities, including coordinating technical assistance, supporting the deployment of assessments and surveys, and organizing workshops and special events. S/he will be responsible for providing timely weekly and monthly reporting of intervention activities to Head of Program.
