Job title: EPI Assistant

Reports to: Clinical Officer

Job Summary

The EPI assistant will work under the direct supervision of the nurse/midwife and will perform generalized duties such as maintaining accurate records and charts, maintaining accurate EPI records including daily and permanent registers, and additional records missed cases and defaulters (prepare and update lists on a monthly basis).working closely with health workers within the mobile facility, health promoters and other staff in order to avoid missed opportunities for immunization of children to be followed up through list and defaulter tracing and coordinating with other team members for proper recording of birth, as well as growth monitoring activities in the facilities.

**Key Responsibilities** 

Conduct static vaccination sessions as scheduled and holding outreach activities

• Administer vaccines correctly in accordance with guidelines, while maintaining strict aseptic techniques.

 Report and record measles cases and conduct immunization mapping up and or any other supplemental immunization activities/campaigns.

- Liaise closely with health workers within the mobile facility, health promoters and other staff in order to avoid missed opportunities for immunization of children to be followed up through list and defaulter tracing.
- Coordinate for proper birth recording/reporting and growth monitoring activities in the facilities in collaboration with other team members.
- Maintain accurate records/charts of monitoring coverage of the patients in the clinic and target population.
- Maintain accurate EPI records including daily and permanent registers, and additional records missed cases and defaulters (prepare and update lists on a monthly basis).
- Provide counseling to care givers on the preventative and curative health aspects of the vaccines, vaccination schedules, when to return for the other shot of vaccine etc.
- Receives vaccine from the county department and ensure that the cold chain is correctly
  maintained to the point of actual immunization in accordance with standardized
  guidelines.
- Prepare monthly statistical report, vaccine consumption/wastage rates and submit in a timely manner.
- Ensure that used syringes, needles and all vaccinations vials are stored and disposed as per protocol.
- Participate in meeting with county department representatives, volunteers and community leaders to discuss EPI activities such as defaulters, EPI campaigns etc.
- Co-ordinate with health promoters on regular basis for defaulter tracing and participate in health education sessions.
- Coordinate with the nutrition wing for the treatment and immunization of the identified malnourished children and their follow up.

## **Project Reporting**

- Provide regular and timely update of immunization and defaulter tracing efforts to the clinical officer in accordance with the set reporting timelines.
- Ensure preparation and submission of weekly vaccination updates to the clinical officer.

- A secondary or high school certificate
- Certificate of attendance in vaccination offered by a reputable organization
- Prior experience in community mobilization for vaccination campaigns.
- Experience in vaccinating and referral for vaccination of children under five, returnees and pregnant and lactating women.
- Positive and professional attitude, able to organize, maintain and prioritize work under pressure and able to work in hardship environment
- Good knowledge of the expanded program of immunization guidelines
- Fluent in the local language and knowledge of local culture are required
- Knowledge of English and local Arabic is desirable.

- Technical experience in a clinical setting
- Good knowledge of MOH procedures and guidelines for primary healthcare centers in South Sudan
- Minimum 1 year of proven experience in health education and health promotion
