

REQUEST FOR PROPOSAL (RFP) SUMMATIVE EVALUATION FOR BHA PROJECT IN SOUTH SUDAN

Background and Context

The project's goal is "improved access to lifesaving and empowerment services to vulnerable groups among IDPs, returnees and host communities through integrated and comprehensive response in South Sudan." In this two-year activity, Alight provides and strengthens on-going, lifesaving services to affected populations in South Sudan by preventing, mitigating, and responding to harm exploitation, and abuse for crisis-affected populations with complementary protection, livelihoods, water, sanitation, and hygiene (WASH) and shelter services, while also continuing to build resilience and supporting the communities to "build back better." These services and support are provided to women, men, girls, and boys with special considerations to the most vulnerable populations such as people with special needs (PSNs), elderly, disabled, IDPs, returnees, and host communities.

Purpose and Objectives of the evaluation

- Alight is seeking applications from qualified applicants (hereafter "evaluator") to lead the summative evaluation of a project funded by BHA during Year 2 of the project. The evaluation is to be conducted in accordance with USAID-BHA Application Guidelines, Revised Draft BHA Emergency Monitoring and Evaluation Guidance, and USAID Evaluation Report Requirements.
- The overall objective of the assignment is to measure the effectiveness of the project (hereafter "activity"). Primarily the evaluation aims to determine the effect of the activity interventions in improving the wellbeing of the target populations and the extent to which the beneficiaries perceive and value the interventions. The evaluation will also evaluate the extent to which the activity contributed to communities' resiliency and self-reliance. The evaluation will also document key approaches that contribute to the achievement of activity outcomes and provide evidence-based recommendations on key actions required for Alight to further improve integrated service provision and building resiliency.

Specific Activities/roles of the consultant

The evaluator will be responsible for defining the most relevant evaluation design and methodology, in line with the Revised Draft USAID-BHA Emergency Monitoring and Evaluation Guidance (April 2021) and USAID's Evaluation Report Requirements, for this performance evaluation and each of its questions. This



will include study design, technique for data collection, analysis, and the study team. It is expected that the evaluator will employ various enumerators to support data collection and that this will be organized, managed, and paid by the evaluator.

Evaluation Questions

The study will try to answer the following key questions:

- 1. To what extent has the intervention appropriately assisted the affected population?
- 2. To what extent do activity beneficiaries perceive and value the interventions in the activity?
- 3. To what extent were communities involved in the activity cycle (design, implementation, monitoring, evaluation, adjustments to approach/implementation based on feedback)? More particularly, to what extent did the activity include representation from all members of a community, particularly marginalized members (e.g., women, girls, the elderly, persons with disabilities, persons with special needs, marginalized ethnic groups within a community, etc.)?
- 4. To what extent has the activity contributed to the communities' resiliency and self-reliance?
- 5. What were unintended consequences of the activity's interventions, i.e., what changes expected and unexpected, positive and negative did beneficiaries associate with the activity's interventions?

For each question, it is expected that the evaluation will include representation from all members of a community, particularly marginalized members (e.g., women, girls, boys, the elderly, persons with disabilities, persons with special needs, marginalized ethnic groups within a community, etc.) as well as assess the activity's ability to include representation from all members of a community throughout the activity cycle.

Evaluation Methodology and Limitations

The evaluator will be responsible for defining the most relevant evaluation design and methodology, in line with the Revised Draft USAID-BHA Emergency Monitoring and Evaluation Guidance (April 2021) and USAID's Evaluation Report Requirements, for this performance evaluation and each of its questions. This will include study design, technique for data collection, analysis, and the study team. The design and methodology will be shared for approval with Alight before data collection is to begin. It is anticipated that the evaluator will employ a mixed-method approach, where both qualitative and quantitative data will be collected. Sampling methodology for qualitative components is expected to employ a variety of primary data collection approaches including interviews, focus group discussions, training pre-and post-tests, and other methods. Anticipated contextual challenges including security risks, seasonal conditions, and network connectivity consistency that may limit field data collection capacity. Adaptations to overcome these challenges will be planned for whenever possible.

The evaluation will take place in activity locations. The evaluator will be responsible for ensuring that confidentiality is maintained and that a safe and respectful environment is provided during any interactions with service users and staff. The evaluator must also share how the data quality, data management, and data security will be adhered to during the evaluation to ensure collected, processed, and raw data deliverables.

- Final data collection tools developed incorporating Alight South Sudan feedback, including a concise data collection guide for enumerators. Translation may be required.



- High-quality data collected, analyzed, and interpreted.
- Draft evaluation report shared with Alight South Sudan.
- Dissemination of results meetings.
- Final evaluation report written and submitted.
- All raw datasets (cleaned and uncleaned) in different formats submitted to Alight South Sudan.

Timeframe

Alight is seeking applicants who can complete the evaluation, including completion of the final report, by February 28, 2022.

Minimum Components and format of Final Report

The final report must include at minimum the following components, as outlined in <u>USAID Evaluation</u> Report Requirements and abbreviated below:

- a. Title page, including identifying the evaluation as a performance evaluation
- b. Abstract
- c. Table of Contents
- d. Abbreviations/acronyms page
- e. Executive Summary
- f. State the purpose of, the audience for, and anticipated use(s) of the evaluation
- g. Describe the specific activity to be evaluated
- h. Provide brief background information
- i. State the evaluation questions
- j. Describe evaluation methodology for data collection and analysis
- k. Describe limitations of the evaluation methodology
- 1. Include evaluation findings and conclusions
- m. Include actionable recommendations based on evidence
- n. Ensure that all evaluation questions in SOW are addressed
- o. Include the annexes as described in <u>USAID Evaluation Report Requirements</u>
- p. Include translated tools or material used for evaluation, if any

The report, its summary, and any datasets produced during the course of the evaluation will be in English. A copy of any dataset created or obtained in performance of this evaluation will be submitted to the USAID Development Data Library (DDL) in a machine-readable, non-proprietary format. The evaluation final report and its summary will be submitted to the USAID Development Experience Clearinghouse (DEC). The submissions to USAID will be done by Alight.

Roles and Responsibilities

Alight Responsibilities:

Alight will be responsible for any support relevant to the development of the data collection tools. Alight will also facilitate visits to activity locations through communication to field staff and relevant authorities. Alight will also be responsible for submissions to USAID's Development Data Library (DDL) and Development Experience Clearinghouse (DEC).

Alight will provide working space and basic office/administrative support in Juba and field offices as needed. All internal UNHAS flights will be booked by Alight, and the billing will be reconciled upon the final invoice submitted by the evaluator. During travel to the field, Alight will provide accommodation and transportation.



Evaluation Team Responsibilities:

The evaluator (evaluation team) will be responsible for all costs associated with conducting the evaluation.

The evaluation team will be leading and managing the data collection and will be responsible for all activities and costs associated with data collection. The evaluator should budget for all necessary expenses in their financial proposal.

Data collection and analysis will be the sole responsibility of the evaluator, but Alight will be involved in reviewing the draft report and included in the final report stage.

Ethical Considerations, Confidentiality and Proprietary Interests

The evaluator needs to apply standard ethical principles during the assignment. The evaluator will be responsible for ensuring that confidentiality is maintained and that a safe and respectful environment is provided during any interactions with service users/beneficiaries, interviewees, and staff. The evaluator must share with Alight their confidentiality policy prior to engagement. The evaluator must also share how the data quality, data management, and data security will be adhered to during the evaluation to ensure collected, processed, and raw data deliverables. The incumbent shall not either during the term or after termination of the assignment, disclose any proprietary or confidential information related to the service without prior written consent of the contracting authority. Proprietary interests on all materials and documents prepared by the contract holder under this assignment shall become and remain properties of Alight.

Evaluation Team Composition

Alight seeks a high-level evaluator with vast experience in conducting performance evaluations for humanitarian activities. Alight may request writing samples that will only be used to evaluate the applicant's experience. South Sudanese nationals with experience are encouraged to apply. It is expected that the applicant will employ various enumerators to support data collection. Below is a key profile that Alight seeks:

- 1. The applicant **must** have experience conducting evaluations in South Sudan.
- 2. The applicant **must** have experience with USAID evaluations particular to BHA (formerly OFDA).
- 3. The evaluation team should consist of team members that possess at minimum a master's degree in public health, environmental health, environmental science, water engineering, social work, statistics, social sciences, public administration, or a related field.
- 4. The evaluation team should include one WASH key technical person and one protection key technical person. These positions can be recruited within South Sudan but should have vast experience of not less than four years with at least one year of conducting evaluations. They should have a minimum of a bachelor's degree in WASH and social work-related fields.
- 5. Applicant lead must have a minimum of eight years of experience in humanitarian and development programming, with a minimum of four years working in humanitarian contexts.
- 6. Minimum of three years of experience in leading performance evaluations, utilizing qualitative and quantitative approaches.
- 7. Must be willing to travel to South Sudan if residing out of South Sudan and be able to work in insecure regions with barely minimum facilities for the duration of the study.



Proposal Components

All applicants must meet the minimum requirements described above. Each application should include a technical and financial proposal as described below.

Qualifications file should include:

- An application letter addressing the selection criteria including how the candidate's previous experience matches the objectives. The application letter should be no longer than two pages.
- Team composition and experience of conducting similar evaluations in South Sudan especially thematic areas like WASH, Protection (GBV) with funding from USAID/BHA, preferably within proposed geographical area. The applicant should have the necessary competencies and experiences as described in the TOR to undertake this evaluation. The applicant should provide the CVs of lead team members with details of qualifications and experience.
- Contacts of three organizations that have recently contracted you to carry out similar assignment
- Samples of work

Technical proposal should include:

- A detail proposal clearly detailing the proposed methodology based on descriptions above especially the sampling method, sampling computation scientifically accepted and the relevant methods of data collections. It is expected that the evaluation will take place in all four project locations.
- Detailed proposal that demonstrates a clear understanding of the TOR and whether the applicant makes an effort to interpret the objectives and the evaluation questions clearly.
- Draft work plan clearly indicating a proposed activity schedule.

Financial proposal should include:

Alight expects a fixed price based on completion and Alight's acceptance of deliverables. It is
expected that the evaluation will include all four project locations and the financial proposal should
reflect all costs associated with data collection in the four locations. It is preferred for the financial
proposal to include a breakdown of costs by project location in the case that it is not possible to
include all project locations.

Criteria for Evaluating Proposal and Selection

The following criteria will be used in evaluating proposals.

Alight will evaluate the responses to the RFP based on the applicants' ability to provide a general overview of their qualifications and their proposed approach to the details contained in this TOR. The proposal will be evaluated as per the percentage allocation below.

The payment schedule will be discussed with selected applicant and will be included in the contract.

Note: Alight reserves the right to accept or reject any proposal received without giving reasons and is not bound to accept the lowest, the highest or any bidder. Only the successful applicant will be contacted.

Additional Information

- Selected applicant shall abide by WHO and Government of South Sudan COVID-19 SOPs while conducting the evaluation.
- Selected applicant shall be required to sign and abide by Alight Safeguarding Policy, including prevention of sexual exploitation and abuse policy.
- Selected applicant shall abide by Alight data privacy/management policies.
