GENERAL POSITION SUMMARY:

The MEL Specialist will perform an integral part of the ELACAP VII team, providing technical guidance and management of MEL activities across multiple WASH ELACAP program locations across Unity Sate counties of Koch, Panyijiar and Rubkona. The specialist will support data collection, analysis, and reporting for all WASH ELACAP activities. s/he will oversee data collection via a variety of tools and methodologist for the program activity results tracking, reporting and adaptive learning including developing additional MEL tools to conduct formative research, baseline assessment and needs assessments, data quality assessments. The holder is expected to travel frequently to the program field sites to coordinate with program teams to ensure MEL procedures and standards are followed though out the activity cycle. Reporting to the Bentiu based Program Manager, the MEL specialist will work in coordination closely with the MEL Manager, project managers, field MEL officers/Assistant and field sites leads for WASH ELACAP VII activities.

1. Support at design programs country strategy based on best practices

2. Provide support at the design stage of program for setting theory of change/logical framework with defined indicators to facilitate the monitoring and evaluations at the later stages.

3. Support the development or program proposal particularly performance monitoring plans and MEL sections

4. Provide evaluation feedback on program documents.

5. Work with the MEL and program teams to developing data collection tools and MEL plans

6. Implement data quality assurance procedures that include but are limited to spot – checking data in the field and cross-checking data from multiple source documents.
