Organization Background

Founded in 2017, the Charity and Empowerment Foundation (CEF) is a non-profit organization committed to addressing the urgent needs of vulnerable populations. CEF envisions a free, empowered, and healthy society where everyone is treated equally. Its mission focuses on enhancing health, combating poverty, eradicating illiteracy, and fighting



discrimination against women through advocacy, training, and innovative service delivery. CEF is implementing a project funded for Lifesaving Protection Services for Returnees from Sudan in Aweil East County and seeks a passionate Child Protection Officer.

Key Responsibilities

- Lead and manage the implementation of child protection activities within the project, ensuring the safety and well-being of children in the target area.
- Conduct comprehensive assessments to identify the specific child protection needs of returnee families and vulnerable children and develop targeted interventions to address these needs.

- Establish and strengthen partnerships with local authorities, community stakeholders, and other NGOs to create a robust child protection network in Aweil East County.
- Develop and deliver training programs for community members, volunteers, and staff on child protection principles and practices, ensuring clarity of roles in safeguarding children.
- Design and implement monitoring and evaluation frameworks to assess project impact, gather data, and provide timely reports on child protection activities and challenges.
- Lead the design and execution of awareness-raising campaigns on child protection issues, focusing on the prevention of violence, abuse, and exploitation, targeting families and communities.
- Advocate for the rights and protection of children within the community, collaborating with local leaders and government officials to foster a child-friendly environment.
- Contribute to the development of emergency preparedness and response strategies related to child welfare, ensuring protective measures are in place for children during crises.

Key Skills Required:

- In-depth knowledge of child protection principles, legislation, and best practices, particularly in humanitarian contexts.
- Excellent communication skills, both verbal and written, with the ability to engage effectively with children, families, and community stakeholders.
- Strong organizational and project management skills, with the ability to work independently as well as part of a team.



- Problem-solving skills and the ability to work under pressure in challenging environments.
- Strong integrity and commitment to PSEA (Protection against Sexual Exploitation and Abuse) principles.

Qualifications and Experience:

1. A degree or diploma in social work, social sciences, or a related field.
2. At least three years of relevant experience in child protection, preferably within a humanitarian or developmental setting.
3. Prior experience working with vulnerable populations, particularly children and families in crisis situations.
4. Preferable consideration for female candidates, given the sensitive nature of the role.

The position will be based in Aweil East County, requiring adaptability to the local context and sociocultural dynamics. The ideal candidate must be prepared to face the challenges of working in a high-pressure environment while maintaining a focus on child protection standards.
