Overview: DAI is implementing a five-year (2019 – 2024) USAID funded program in South Sudan with its main office in Juba and sub-offices in Aweil, Torit, Wau and Yambio. The Feed the Future Policy Leadership, Interactions, Networks and Knowledge (Policy LINK or LINK) project will strengthen the capacity of local actors and institutions to lead and manage the agricultural transformation process and contribute effectively and collectively to improved, broad-based food security policy outcomes.

Specifically, the program aims to strengthen food security policy systems by investing in and reinforcing productive human and social capital and developing strategic partnerships that help bring these innovations and capacity investments to scale in order to achieve a critical mass of local actors with the ability and opportunity to effect positive policy change through collective action.

Attachment C: Technical Specifications and Requirements

1. Project background

DAI Global LLC, implementing the United States Agency for International Development (USAID)—funded five-year technical assistance project titled Feed the Future Policy Leadership, Interactions, Networks and Knowledge (LINK).

Under the Link award, DAI provides expertise in strengthening the capacity of local actors and institutions to invest in and reinforce human and social capital, through collaborative governance and collective action.

In South Sudan, LINK provides backbone support to the Partnership for Recovery and Resilience (PfRR). PfRR is a cross-sector, multi-donor, multi-agency platform and collective of partners established to increase the agency of local populations in select geographic areas to identify and respond to their priority needs for building resilience and reducing vulnerability. With this approach, the community, local governments, and donor agencies are improving their use of evidence to inform joint decision making at local, national, regional and global levels, as well as strengthening community capacity to withstand and respond to shocks.

DAI Global LLC is registered in South Sudan with the Ministry of Justice as a foreign branch office (registration number 589). The branch office is used solely for the purpose of implementing activities related to LINK. The activities conducted under the branch do not generate any income or profit in South Sudan and are tax exempt under the agreement for economic and technical cooperation signed between the US and South Sudanese Governments at Juba September 11, 2012.

2. Purpose of this Request for Quotations (RFQ)

The RFQ objective:

The objective is to procure financial audit services for the DAI Global LLC foreign branch in South Sudan as required by the Companies Act. The appointed firm will be required to produce an auditor's report and financial statements that comply with International Accounting Standards.

3. Scope of Work

The appointed firm will be required to:

- Qualified Accountant, holding current membership of an internationally recognized accounting institution, e.g. AICPA, CA, ACCA or equivalent;
- Minimum of eight (8) years relevant experience;
- Fluent in English language

- ✓ **Senior Accountant**

- Graduate of a university in the fields of finance, accounting or auditing;
- Minimum of five (5) years relevant experience;
- Fluent in English language.

6. Contract extension

DAI may need to receive the services of the firm to prepare the financial statements of the 2022 fiscal year in the future. DAI may contact the firm if it deems satisfied by the current services required.

7. Payment terms

The firm will be paid in full after delivery completion within 30 days upon submission of invoices by wire transfer.
