Finn Church Aid was founded in 1947. The organization is specialized in long-term development programs and humanitarian assistance.

FCA is seeking for quotations for supply of wash facilities for COVID-19 and Ebola awareness in FCA supported TVET institutions and primary schools in Lainya, Yei and Kajo Keji. The delivery locations will be FCA offices at Juba Na Bari opposite Nile Fortune Hotel for Kajo Keji Wash facilities and FCA Yei office located at ECSS Guesthouse compound, Hai Mission Road for Lainya and Yei Wash facilities. The quotation should include delivery cost to FCA Juba office and Yei, Central Equatoria State.

You are required to submit your quotation in a plain sealed envelope clearly marked with the RFQ number 12229/0026/2023 and dropped inside the box placed at FCA security room in Juba or Yei or send via email to <u>procurement.ssuco@kua.fi</u>. All quotations delivered by hand should be registered in the submission register before dropping in the box.

When submitting a quotation, vendors should take into account the following:
