**Purpose of the Position:**

The primary responsibility of the Nurse Midwife is to support the effective implementation of quality health programming, including direct care as necessary and evaluation of program activities and to provide support to the target communities in addressing specific health activities meant to improve access to quality and equitable health services to the health facilities catchment area populations including supporting training/capacity building of the health facilities staff.

**Major Responsibilities:**

- Establish cordial relationship with county health department and promote proper coordination
- Overseeing the health activities in Pochalla and ensure there is a proper coordination of mobile outreaches and ICCM
- Regularly monitor the health and nutrition sites including Stabilization Centre to ensure services delivery are implemented in line to the country policies
- Schedule and train Runit PHCU staff on IMNCI and provide continued on job training
- Network and coordinate with the relevant units in the hospital

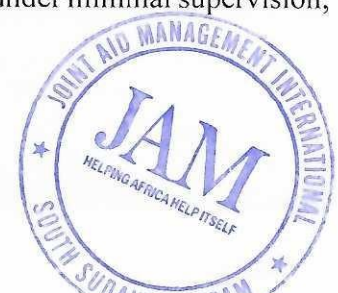




- Participate in weekly and monthly CIID coordination meeting and update the health coordinator
- Support the mobile team to conduct integrated community outreaches in all the designated villages in Pochalla
- Work closely with SC, Nutrition and IPD staff to ensure all SC protocols are understood and agreed and appropriate referrals take place to and from the OTP.
- Participate and disseminate public health and Nutrition health education messages to improve, attitude and practice of the community in Pochalla.
- Support in surveillance of epidemic-prone diseases and reporting accordingly.
- Ensuring that regular inventories are conducted, and proper storage according to recommended standards. Monitor rational use of drugs periodically in comparison with morbidities.
- Collect health statistical data and narrative reports from JAM supported facility and ICCM program.
- Review all the nutrition and medical reporting tools and standardize all tools as per protocol.
- Supportive supervision to all health facilities, using standard checklists and in liaison with MoH.
- Produce timely weekly and monthly project update reports and proper internal reports for the coordination team.
- Carry out additional responsibilities as assigned.

**Key Qualifications:**

- Diploma in clinical medicine from the recognized institution or relevant qualification
- Diploma in Nursing from a recognised institution with experience in primary health care program;
- Thorough knowledge and skills of primary health care services and related programs in rural situations;
- Experience in overseas programs relating to primary health care, maternal and child health, reproductive health, HIV/AIDS, and communicable diseases
- Ability and flexibility to understand the cultural and political environment and to work well with local health representatives
- General understanding of health service delivery, especially those related to women and Children;
- Proven analytical, problem-solving skills and comfortable working under minimal supervision;

- Fluent in written and spoken English and can speak local Arabic
