The Operations Manager will be responsible for:

Operations and Logistics:

- Work with the Programme Managers, and the Senior Responsible Person to OUTH
- ensure compliance with operations, procurement, logistical and security procedures

- Ensure that the country office operations, logistical and security support requirements are met in an efficient and timely manner

- Overall management of a team of operational staff, including drivers
- Ensure the programme team receive adequate operational and logistical support to conduct all programme activities
- Enforce the application of Mott MacDonald procedures as per the programme manual
- Assist with supervisory oversight of the procurement process
- Other duties as may be assigned by the Programme Manager/ Senior Responsible Person

- Brief employees prior to their deployment to the field and debrief upon return
- Ensure Mott MacDonald Security Protocols are written, communicated, established and effective in each work
 location and for travel in order to minimise potential risks, primarily to staff safety and security and also to

- Monitor, evaluate and assess the safety and security environment and devise risk reduction measures as appropriate, in coordination with DCM; Project Principals; Project Managers; Program Security Officers and Unit/Regional Security Offices.
- Assess security protocol compliance in project offices where Mott MacDonald staff are resident or
 occasionally visit; sites and travel routes for their security requirements and make necessary arrangements
 in coordination with related managers.
- Liaise with requisite Governmental Agencies and Projects to facilitate NOC or Registration process, work with
 and on behalf of staff who require security assistance, liaise with associated security organisations (such as
 CRG, Insight Security).
- Provide any security related reports including weekly/monthly security reports and produce project and travel risk assessments.
- Develop and implement security policies, protocols, and procedures
- · Train and collaborate with security officers from partners and state anchors
- · Coordinate security, first aid and fire-awareness trainings for including period safety drills
- Manage safety and security of all staff when travelling for programme activities including risk assessments, appropriate journey planning, emergency procedures and safety equipment are provided
- Manage/oversee health and safety of office premises including regular spot checks
