Job Summary

The **Heavy Plant Grader** Operates the organisation construction equipment to execute work related assignments, excavation and hauling of construction materials as well as other duties as assigned. Operates the Grader and any of the heavy plant machinery at least the Excavator, wheel loader and back-hoe. Responsible for keeping the heavy plant machinery including the low bed – heavy wide load truck to the highest standard in accordance the maintenance interval.

Duties & Responsibilities

- Carry out daily inspection of the heavy plant machinery allocated before starting the engine, checking leakages, lubricants, greasing, water levels, coolant, wheels, tightening all bolts and nuts.
- Responsible for the heavy plant machinery documents and their good condition, keeping the logbook, weekly, monthly maintenance records influence refuel records.
- Ensure weekly checks of heavy plant machinery is carried out (cleaning of air cleaner, through washing and cleaning of the machinery)
- Reports to immediate supervisor any need for minor repairs and maintenance of the heavy plant machinery (grader) after every task performed.
- Safely and responsibly performing all earth moving/hauling works using official equipment.
- Taking account of all available information on quarry/material sites, road conditions, accessible routes and locations.
- Make sure that tachometer/ hour readers are properly functional and any faulty noticed is immediately reported to the Logistics /immediate driver in charge of the vehicle fleet in the organization.

- Carry out assessment of the task working areas first before engaging the machines to dangerous elements that can damages tyres and horse pipes
- Take in account all available information on behaviour of the heavy plant machinery during operation on the roads works and locations.
- Complete the heavy plant machinery's log book correctly and conscientiously in accordance with AAH-I standard.
- Respect and work within the South Sudan traffic rules and regulations and report immediately any accident that occurs.
- Ensure the cleanness of the heavy plant machinery with keen observation of safety precautions during cleaning of the heavy plant machinery.
- Operation heavy plant machinery in accordance with instructions and directives from supervisor.
- Avoid idling, aggressive operation actions, over speeding, night movement and other activities that might damage the reputation of the organization.
- Avoid operating heavy plant machinery under influence of alcohol and drugs
- Comply with operations' work rotation in accordance to work plan has been provided by the supervisor.
- Deliver service to the partners approved requests in the operation in a smooth way as expected
- Responsible to use all available information (including current radio news on traffic conditions) to update daily knowledge of operating areas conditions, current possible routes and locations, and shares the information with the immediate supervisor.
- Assist in any other work assigned by the management.

Routine/Daily Tasks

- Clean the interior/exterior and greasing of the assigned machinery regularly before and after use.
- Check all oil, water, brake, hydraulic oil, brake fluid, tyre pressure, coolant, battery levels and the entire general routine weekly and monthly machinery check-up and submit report to the immediate supervisor for routine maintenance.
- Reports need for service and carries out minor repairs.
- Immediate report submission in case of an involvement of the machinery in accident, including minor accident, damage, loss or theft of property and parts.
- Respect all traffic rules and regulations
- Respect speed limit while operating especially on roads, quarry/ borrow pit, any trading centres and animal crossing gazetted areas. OF LAR
- Ensure that security measures are respected.
- Maintain-authorised Machinery's tachometer. Any alteration, fuel siphoning and loading of un authorized goods and passengers will result in to termination.
- Ensure Radio is on all the time while operating machinery for communication and follow all communication throughout the Radio communication channel.
- Comply with all security update and instructions. Report to the office any threads to the best of your knowledge.
