Job title: Mine Awareness Officer

Purpose of the position:

Mines and UXOs pose a serious threat to safety and may cause injury to communities, especially children who may mistake these as objects for play and not recognize the danger. Mine Risk Education is designed to help adults and children learn to the dangers of mines/UXOs, how to recognize, report and mitigate mine risks at community level. The Mine Awareness officer will supervise Mine Awareness Assistant in Mangala. He/She is responsible as the main liaison to the community, supervision of the MRE Team in Mangala, development and implementation of weekly MRE work plans and education sessions. The Mine Awareness officer should ensure the use of age and gender appropriate education and communication strategies are used, including child-friendly. The position is also responsible for all information recorded, required reporting and IMSMA updated.

Key Job responsibilities

- Leadership of MRE Activities – Collaborative planning & development of weekly work plans, supervision of Mine Awareness Assistant, establishment of community-based marking & reporting systems.
- Primary liaison to community, Mine Action actors, NMAA – Joint planning, coordination, information sharing.



- Provide Mine Risk Information sessions / presentations, as required and record the impact of WV-SS work and the need for future work through the collection of case studies, photographs, needs assessment and evaluation reports.
- Collect accident or incidents data and liaise with hospitals, victim assistance organisations, and coordinating bodies.

Qualifications/Education/Knowledge/Technical Skills and Experience

The following may be acquired through a combination of formal or self-education, prior experience or on-the-job training:

- Bachelor Degree in Social work, International Relations, and Social Sciences.
- At least Accredited Certificate in Mine Risk Training with Secondary school certificate preferred.
- Strong experience in conducting Mine Risk Education is **STRONGLY** preferred.
- Strong experience and knowledge in conducting Mine Risk Education.
- Strong knowledge on giving first aid.
- Must have a love for children and demonstrate patience, tolerance, problem solving, open-mindedness and interest in social justice.
- Basic written / speaking English strongly preferred
- Local language as first language strongly preferred
