Key tasks & responsibilities	<p>FCL is planning to install water system at Palotaka which will be motorized by solar power from existing borehole and therefore we inviting competent and reputable bidders to submit their quotation as soon as possible.</p> <ul style="list-style-type: none"> • Assess the feasibility to use existing electrified pump borehole at Palotaka Holy family Parish - and therefore there shall be no need to drill new borehole. • Erect two (1) Plastic water 5000 litres water tank, with overflow pipe • Elevated steel tower with climbing ladder for minimum 5 metres from ground. • Supply of water from the tank using HDPE water pipes to the office, Parish and for communities about half a kilometre (km). • Construction of 3 (one) water point with drainage channel. • Installation of solar panels to be used with existing electric water pump • The bidder has to verify the pressure capacity and the quantity of water of the existing borehole before installation. • The distance from Borehole to the office is 100metres • The distance from Borehole to the parish residence 400 metres • The distance from Borehole to community 250 Metres
