# **Project Summary:**

The South Sudan Monitoring and Evaluation Support Project (MESP) will conduct a baseline household survey to gather data for indicators included in the new USAID South Sudan Mission country strategy. The indicators are part of the performance management plan for USAID/South Sudan's strategy in the country, which will serve as the Mission's tool for effective management of results in order to achieve the best possible development outcomes that allow for evidence-based decision making, learning, and adaptation. The baseline household survey will be implemented in seven counties – Baliet (Upper Nile), Jur River (Western Bahr el Ghazal), Kapoeta North (Eastern Equatoria), Mayendit (Unity), Panyijiar (Unity), Ulang (Upper Nile), and Wau (Western Bahr el Ghazal) – between July and September 2021. MESP requires 10 Language Consultants in Azande (1), Balanda (1), Bongo (1), Burun (1), Buya (1), Chad (1), Jur-Chol (1), Ndogo (1), Shilluk (1), and Toposa (1).
