Action Against Hunger focuses on nutrition, health and healthcare practices; food security and livelihoods (FSL); water, sanitation and hygiene (WASH) and advocacy.

## Summary of position

Under technical supervision and guidance of Mission health specialist, the Emergency Roving Medical Doctor provides support in operationalization of health program activities in Multisectoral Emergency department through direct delivery of health services, technical support, building capacities of staff and liaise with the focal points at state and national levels for efficient management and functioning of program/services on ground. A caring and compassionate nature and the ability to deal with emotionally charged and pressured situations are important traits of this Position. The Emergency Roving Medical Doctor role is designed with the following purpose, engagement and delivery:

#### Purpose:

The Emergency Roving Medical Doctor position will be overseeing the implementation of all the Health activities under Emergency Program, as per South Sudan Health technical strategy. He/She will lead in the identification of new, creative and innovative opportunities in health programming within the Emergency deportment and remain directly responsible for provision of quality health services as per the validated standards of practice and guidance and policies of South Sudans' Ministry of Health and WHO. He/She will oversee and support the health and medical activities under the Emergency Department, including but not limited to: Clinical management of the patients (OPD, in-patient, OTP/SC cases management), prevention activities (EPI, ANC, PNA, etc.) reproductive health, team supervision and capacity building, data collection & management, including timely reporting. Can lead the deployment in absence of Health and Nutrition expert or designed team leader.

#### **Engagement:**

Work alongside the Head of Emergency and mission's Health Specialist to capacitate staff and adhere to South Sudans health Strategy, and MoH's Health policies and guidelines, in addition to validated Health Cluster's recommendations in absolute respect to organizational procedures on HR, finance, logistics, security, programme and other technical guidelines/guidance as appropriate. The incumbent, ideally, should be able to respond to and resolve complex service delivery process enquiries, and timely raising issues affecting the delivery of the services

#### Delivery:

Consistent in respecting policies and procedures for effective implementation of all medical and Health program activities across all emergency deployment areas in line with South Sudan's Health Strategy and MoH policy and regulations, ACF standards and international program requirements with regards to Health. She/She will coordinate and direct the implementation of health sector services under Emergency Department in line with the donor), donor agreements and contracts. He/She will deliver quality health services delivery in line with beneficiaries' needs and that meet the standard performance indicators. He/She must be innovative through creation/adopting new process/approaches that support concrete/objective and quality services delivery that upholds the organization reputation; constant in coordination, reporting and proposal development.



## **Essential job functions:**

# Objective 1: limplementation and follow up health activities in the framework of Action Against Hunger Health and nutrition programs, with a specific focus on its health programming (60%)

- Responsible of quality implementation, technical support to the team and follow up on delivery of all health activities in any emergency deployment. In this regards, he Oversee the day to day health program activities implementation under emergency department.
- o In line with approved guidelines from MOH/WHO, provide technical advisory support on health related issues to the field and health facilities teams as well and in OTP/SC sites in any emergency deployment.
- Technically support the medical team at the stabilization centre in the diagnosis, and treatment of SAM cases, with medical complications eligible for admission at the SC in strict adherence to the SC/ITP guidelines for treatment of SAM cases.
- The medical roving Doctor will be responsible of medical specific hygiene and sanitation protocols and practices in supported health facilities as well as OTP/SC sites. In this regards, he should Ensure health team adhere to high standards in infection prevention (IPC), including adherence to universal precautions by all staff, proper equipment sterilization, as well as guidelines for and adherence to waste segregation and proper disposal perform any other duty assigned by line manager.
- Supervise and provide technical support to ensure proper referral and follow-up of children under 5
  SAM with medical complications to higher hospitals and back
- Train and support the team in collection and compilation of mortality audits reports at treatment sites and ensure findings are used for improved programming
- Technically Support and operationally coordinate the referral process for cases that need further treatment/management.

## Objective 2: Supervise/team management and assistance (25%)

- In consultation with the health specialist, advise on the requisition of essential equipment and medical supplies for emergency health response.
- Actively participate in internal meetings on health program under Emergency program while following up on concerns and action points.
- Train and provide on job support to the team to ensure consistent readiness, responsiveness and quality of health program activities implementation.
- Develop routine staff activities schedule including daily and weekly activities and meetings.
- Ensure health team under his supervision adhere to both technical guidelines as well as HR, Logistics, Finance, security procedures and policies.

# Objective 3: Stock management of the pharmacy (drugs and medical supplies (5%)

- o In collaboration with the health specialist, make orders for drugs and medical supplies and follow up for their release from the store for dispatch to the teams in the field.
- Coordinate and support the preposition of drugs, medical supplies & equipment before any emergency deployment.
- Manage all the pharmaceutical supplies and drugs in all the emergency deployments, including supervision of pharmacy/drug inventory and stock reports for SC, OTP/TSP..
- Support and supervise the procurement of drugs, medical equipment and other supplies needed for multisectoral emergency team activities collaboration with health specialist.
- Organize and track the utilization of all drugs and medical supplies used for health facilities, and maintain the pharmacy/drug store within an acceptable conditions.

## Objective 4: Reporting and coordination (10%)

- Ensure data are timely reported to technical/line manager: submit all the verified reports under health sector: ISDR &DHIS, weekly updates, and monthly reports. After validation, report to CHD or existing partners for upload on DHIS
- Track and document all accomplished health activities, and prepare and submit regular reports within the set deadline i.e weekly updates, monthly reports, metuding monthly pharmaceutical items consumption report, weekly/ monthly morbidity and mortality reports.

- Conduct data quality checks/ audits and take timely corrective measures, and feedback to the field team and technical/line manager.
- Support data management at national and base level on relevant health indicators including basic analysis and data use for decision making
- Contribute in health project design and proposal writing, and donor report, particularly under health
- Represent Action Against Hunger in health cluster, at the national and state levels, and partners meetings in any emergency deployment.

#### **Physical Demands**

To travel to the field, the employee must attest to a level of physical fitness capable of enduring physically difficult, highly stressful situations, which may include the necessity to walk long distances, to eat a limited diet and/or to reside in potentially uncomfortable housing or tents.
