The position is a (6) months position with the possibility of further extension subject to performance and availability of funding.

PURPOSE

Mechanical workshop management.

- Maximises the fleet efficiency and effectiveness through planned preventive maintenance, service, and repair in accordance with guidelines issued by the Fleet Officer or in accordance with manufacturer recommendations.
- Full knowledge of the mechanical/electrical preventive maintenance, operation and repair of vehicles, generator, and equipment by the following brands of Vehicles (Toyota Harrier, Toyota Hilux, Toyota Landcruiser 4x4, Iveco truck with 8t Crane and Caspir Mercedes truck MPV (Mine Protective Vehicle), Quadbikes, Motorbikes, Motorized Canoes and Generators of various makes, brands and models.
- Troubleshoot, Identifies, and lists spare parts required according to diagnose and ensures in collaboration with the Fleet Officer that required parts are supplied to workshop.
