Background

Reasons for seeking partnership

As part of our community development, Tearfund South Sudan wants to expand our work in Waste Management in Juba City. We are looking for a local partner and/or a company for a potential partnership to operate and maintain the water bottle crushing machine. The selected organisation/company will work with Tearfund to implement Waste Management activities in Juba County.

You are eligible to apply if you meet the following Criteria:

You are:

 A registered non profit national organisation, social enterprise or a company that is operational in South Sudan.

 Registered and can legally operate in South Sudan (e.g. South Sudan NGO Forum, RRC, Chambers of Commerce, Juba City Council)

 Have waste management projects and a well established and physical presence in Juba County, Central Equatoria State.

 Have strong internal control systems and policies essential for effective management of donor funding.

Have an up to date audited accounts for last financial year.

 Have a clearly identifiable physical location with basic assets and equipment to enable operations.

Must own adequate land and space in Juba for the waste management facility.

 Committed approach to Safeguarding (Children and Adult at risk) including policies and procedures

 Committed to respecting and upholding the rights of waste pickers who work in the informal waste sector or in cooperative settings

Able to provide at least two reference organisations worked with and their contacts.

- Have programmes that can be aligned with one or more of Tearfund's thematic goals, specifically Environmental and Waste Management, and Women and Youth Empowerment.
- Proven experience on waste management in South Sudan.

Women-led and youth-led organisations and companies with significant experience in environmental and waste management are strongly encouraged to apply.

Interested organisations and companies who meet the eligibility criteria are required to submit their Expression of Interest to Tearfund South Sudan through the Coupa system.

Applications & Submission of Bid: submit Bid documents only to Tearfund through Coupa following the steps in the system that include:

- b) Accepting Tearfund Terms & Conditions after reading through
- c) Click enter my responses- where you will provide your company details & work on the pricing accordingly.
- d) Finally submit the bid.

Closing date: The closing date for submission of completed bid documents is on 23rd May 2024 at 18:00 hrs. The system will show you clearly the remaining number of days and hours accordingly in order for you not to miss submitting your bid online.
