Plan is an International Child Centered Community Development organization – without religious, political or governmental affiliation – that works with children and their communities in 50 of the world’s poorest countries to make lasting improvements in their lives. Plan’s work worldwide benefits around six million children in Africa, Asia and Latin America. Program implementation takes place in 50 Country Offices and 4 Regional Offices, working with more than 90,000 mostly rural communities.

Working in 50 developing countries across Africa, Asia and the Americas, Plan has ‘One Goal, whose aim is to reach as many children as possible, particularly those who are excluded or marginalized, with high quality programs that deliver long-lasting benefits by increasing its income, working in partnership with others and operating effectively.

Plan recognizes that the geographical context and recent history have left the communities of South Sudan highly vulnerable to emergencies from political and inter-ethnic conflicts, influx of returnees, food insecurity, long dry spells and floods. Cognizant of the need Plan is implementing emergency and recovery response in six states of South Sudan, namely Central Equatorial, Eastern Equatorial, Western Equatorial, Lakes, Upper Nile and Jonglei. Program includes food assistance, agricultural rehabilitation, Food Security and Livelihood, Education in Emergencies and Child Protection in Emergencies.

### Purpose of the Role

The Food Security and Livelihood and Nutrition Coordinator is part of Plan South Sudan’s Emergency Response Team based in 4 locations Yei, Lainya, Magwi and Rumbek East to facilitate cash transfer for food assistance programs targeting children, youth and adults in emergency affected areas. In particular, the person applies principles of ensure that a sound management, internal control systems and procedures are in place for the smooth running of Plan's FSL programming.

## Roles and Responsibilities

- Coordinating the Emergency response team in the county in delivering the project outcome.
- Conduct training on FSL and Nutrition with guideline on existing national nutrition and county curricula
- Developed monthly work plan for each week and supervise implementation of the project with support from the ERM team.
- Work with county Agriculture department in the delivery of sustainable approaches to Cash assistance for food response and supporting selection of beneficiaries.
- Ensure that the project is properly implemented and monitored with support from the M&E teams through frequent field visit and support.
- Support in the identification of the vendors for seed testing and distributions for the available local farmers.
- Ensure farmers are identified and registered for the seed fare and conditional cash transfer using the right selection criteria.
- Coordinate with other thematic managers i.e. CPIE, Education, SRHR, for the projects in order to manage and supervise the progress and
- Take lead in representing Plan International in all the county FSL and Nutrition forum with other partners and relevant government sectors.
- Coordinate and ensure that the projects administrative processes, such as logistics, procurement and policies are fully implemented according to Plan International donor's requirement.
- Support the ERM team in developing the Detail implementing plan for the project.
- Act as a focal persons in the area of jurisdiction with full mandate to implement the project on behave of Plan International.
- Support in the development of any ERM FSL proposal and assessment in the time of needs.
- Submit Narrative and financial report for the project on quarterly and annual report.
- Follow-up on monitoring the budget performance through the generation of BVA and alignment to the cost.
- Support the creation of the project outcome in the systems.

### **Dealing with Problems:**

FSL officer deals with issues at his/her level and reports issues from time to time to the Emergency Response Office for proper intervention. This involves tolerance in working under pressure at the level of the head office and the field office. She/he should be able to make appropriate decisions that are in the best interest of Plan International.
