This Invitation for Bids (IFB) has been issued by the South Sudan Red Cross (the Client/Owner). The South Sudan Red Cross (SSRC), with funding from Netherlands Red Cross is planning to install two boreholes with solar powered submersible pumps in Terekeka branch in Terekeka town in Terekeka County of Central Equatoria State for drinking water supply as per the detailed specification described herein.

The Owner is seeking a qualified and experienced drilling company to carry out the work and provide proper tools, machinery, materials and labor for submersible pump installations, tower constructions, PE Tank of 5000 Litres installation and two tap stands constructions with three taps as per drawings and specifications set out herein.

The Owner invites qualified Bidders to submit sealed Bids for the execution and completion of **the two borehole Installation with solar powered pumps**. Prices quoted should be net, inclusive of all taxes, must be in USD shall be irrevocable, valid for acceptance by the Selection Committee for a period of ninety (90) calendar days from the Deadline for Receipt of Submission of Bids.

Bidders are required, as part of their Bid to submit Bid Security of **2,000 USD** (two thousand USD) in the form of a banker's cheque addressed to the South Sudan Red Cross.

Bidders must comply with the conditions and instructions contained in this IFB and its Instructions to Bidders and failure to do so may result in disqualification or rejection. A Bidder will be selected pursuant to the bidding procedures described in this Invitation for Bids. Please note that a Pre-Bid Conference will not be held. **Potential bidders are asked to collect the complete bid documents on a flash disk at SSRC HQ offices.**

All Bids shall be delivered by hand or by courier in separate SEALED ENVELOPES pursuant to the terms and conditions of this Invitation for Bids no later than **17th May 2022 at 2:00 pm** Central Africa Time Zone (UTC+2) at the headquarters the South Sudan Red Cross. **Bids shall be valid for 90 days from the date of submission.**

Bids will be opened the same day and at the place specified above. Representatives of the Bidder may be present to submit their Bid and may be present while the unopened Bids are inspected to confirm that none have been tampered with. Bidders are not invited for the opening of the Bids.

Submission of Bids by facsimile or e-mail is not acceptable. Late Bids will be rejected and returned unopened.
