Action Against Hunger-USA is part of the Action Against Hunger International network, which provides humanitarian relief in over 40 countries worldwide in the sectors of nutrition, health, water/sanitation, and food security. Action Against Hunger-USA, an independent NGO, currently manages operations in seven countries: Kenya, South Sudan, Tanzania, Uganda, Ethiopia, Haiti and Somalia. Action Against Hunger-USA has approximately 1,500 staff based in the various country offices, Head Quarter in New York City and Operational Centre in Nairobi. Additional growth is anticipated.

SUMMARY OF POSITION I.

Under supervision of Nutrition and Surveillance Expert, the Nutrition and Surveillance Programmed Manager role is ensuring quality surveys conducted; represent Action Against Hunger at NIWG and other platforms; support in proposal development and donor report writing.

PURPOSE

To provide overall leadership and management for the Nutrition Survey; the role holder will be responsible for designing, planning, conducting, analyzing and report writing of SMART survey, rapid nutrition assessment, and coverage survey activities. This will be in the priority areas /Counties as identified and agreed with the Nutrition Cluster/NIWG. This role will work with the country NIWG in coordination, planning, monitoring, data collection/management and reporting of nutrition activities.

ENGAGEMENT

Engage with program Expert, manager, Heads of Departments, Multi-Sectoral Emergency Team (MET) and heads of bases to strengthen the Surveillance system; represent Action Against Hunger in NIWG and other similar platforms as well as support in project proposal development and donor report

DELIVERY

In line with the Action Against Hunger Charter of Principles, Safeguarding and Core Values, the Nutrition and Surveillance Programme Manager will:

- Execute and implement quality SMART surveys (nutrition surveillance) to strengthen evidence and learning in order to maximize the impact of Action Against Hunger South, Sudan programs to the beneficiaries and inform South Sudan humanitarian community for analysis and
- Provide quality and timely technical support throughout the project cycle implementation.

II. **ESSENTIAL JOB FUNCTIONS**

1. Support Nutrition assessment strategy and SMART survey activities / Overall management of the

SMART surveys implementation and Capacity Building to partners:

In close collaboration with the Ministry of Health, Nutrition Cluster (NC), NIWG and all nutrition partners, to strengthen the nutrition information systems in South Sudan to contribute to information availability and feed to the regular humanitarian bulletins, IPC analysis, etc.

- More specifically, in collaboration with the Ministry of Health and UNICEF, to actively contribute to strengthening of the NIWG and its functions (survey methodology validation, data analysis, data and report validation process, results dissemination, etc.)
- To provide support in the identification and articulation of the survey needs of partners implementing nutrition programme in South Sudan, particularly during humanitarian crisis in
- To provide technical support on-the-ground or remotely to partners implementing nutrition assessments/SMART surveys and nutrition surveillance systems, notably for initial survey planning, sampling strategy, recruitment and training of survey teams, technical support for data management and analysis, and validation of reports.
- To coordinate with South Sudan NC, other partners and other nutrition coordination mechanisms such as NIWG on the necessary human and financial resources required to
- To ensure collaboration with key governmental authorities (Ministry of Health) and other relevant sectors (e.g. nutrition agencies, UNICEF, other INGOs).
- To support to stakeholders in ensuring training, supervision and data collected from the quarterly Food Security and Nutrition Monitoring Systems and more specifically the nutrition
- Identification and design of surveys activities in Action Against Hunger operational areas according to needs/pre-decided work-plans (and capacities that includes SMART survey methodology and other nutrition surveys if needed).
- To prepare Action Against Hunger SET survey planning, ensure timely implementation and overall coordination with NC and NIWG.
- Prior, during and after the implementation of each nutrition assessment/survey, ensure involvement of State and County Health Department (CHD) staffs
- To support and supervise the actual data collection activity both at technical and operational
- To ensure that the survey tools and methodology (design and sampling) are used in the field and are in line with the validated by the NIWG, and ACF HQ Nutrition Technical Advisor (TA).
- Responsible for the survey design: initial planning, selection of tools and methods, sampling, writing guidelines and set up time frame, working days needed, budget and logistics planning and any special tools and equipment needed.
- To recruit, train and supervise SET members (data collection team, etc.).
- To coordinate survey team members' work and operations; provides technical support to the field teams on a regular basis during rounds of survey; and share lessons learned with NC
- To coordinate the data analysis, result interpretation, and report writing with the nutrition surveillance expert, NIWG and ACF HQ advisor.

Is responsible for survey report production and results dissemination



To supervise the evolution of the SET approach and re-orient program if needed, in discussion with ACF Nutrition and Surveillance Expert, Programme director, Head of health and nutrition Department, HQ Nutrition TA, and the NIWG.

2. Conduction of surveys/assessments:

The Nutrition and surveillance progrmme manager is responsible for conducting surveys/assessment and ensuring their methodological and scientific soundness, as well as conducting data analysis and reporting in collaboration with MEAL and Nutrition, surveys and assessments team within Action

- Design the survey (survey protocol/proposal): The nutrition and surveillance programme manager is in charge of: developing the survey proposal, selection of tools and methods, type of informants, sampling method, selection of villages for field work, writing guidelines, set up time frame/ working days needed, logistics planning and any special tools needed (communication means, map, camera) to conduct surveys and assessments. Enumerators and team leader training: at field level, facilitate identification, recruitment and training of local survey enumerators and team leader trainings.
- Field work (data collection): collection of information at field level. The nutrition and surveillance programme manager will systematically provide the team training before the field work to test the questionnaire and methodology and to ensure that the team adheres to guidelines, protocols and methodologies in place.
- Collection of background and general information: Under supervision of its line manager, the nutrition and surveillance programme manager is in charge of the scientific quality of the secondary information (e.g.: population figure). S/he will organize for ACF nutrition staff members access to information such as surveys HH questionnaires/questionnaires, surveys raw data, validated reports, results of key informant interviews, local authorities interviews, and according to the need as expressed by ACF nutrition staff members..
- Analysis and processing of information: particular attention will be paid to the nature of the data to be collected, ensure data entry is done on a daily basis, and run plausibility checks to provide feedback to survey teams, and correct any mistakes identified. Main tools used for data processing are ENA for SMART and excel. The nutrition and surveillance programme manager will assist and lead the team in data entry (where needed) and analysis.
- Reporting/Dissemination/archiving: The nutrition and surveillance programme manager will be responsible for writing the survey report and finalize the report. The report should always be completed within a week after end of data collection and submitted to NIWG for in-country validation and for dissemination. Archiving: The nutrition and surveillance programme manager is responsible for keeping records/archives of all reports and data collected.

3. Management of Survey Teams

- In collaboration with HR department, recruit SET survey teams. Ensure follow-up of SET survey team (field recruited staff members): provide induction, define individual action plans, follow-up on leaves, conduct appraisal, and promote positive team dynamics and motivation.
- In collaboration with the HR department, ensure the support to the field teams for all matters
- Build technical capacity of the survey team: identify training needs, define training contents / methodology and conduct trainings for the team.

4. Collaboration with Action Against Hunger team

- Follow up of program budget in liaison with the the nutrition and surveillance Expert and
- Follow up of the logistics requirements of the Survey team with the Logistics Department and relevant Heads of Base/ Field Coordinators.
- Collaboration with Technical Coordinators and Program Managers and any other Action Against Hunger resource people in order to ensure the coherence of Action Against Hunger

activities and reports while ensuring integrated multi-sectoral proposals are based on emerging field evidence and guidelines. Ensure effective implementation at field level.

Provision of nutrition technical support based on needs identified by Technical Coordinators

SUPERVISORY RESPONSIBILITIES III.

The nutrition and surveillance programme manager will directly be the line manage of daily hire survey teams at the field.

IV. PHYSICAL DEMANDS

While performing the duties of this job, the employee is required to sometimes sit for long periods and to concentrate on work, including typing, and turn out heavy volumes of work accurately, within short time frames under stressful situations. Must be able to proofread own work accurately so that only minor corrections are needed on an infrequent basis.

To travel to the field, the employee must attest to a level of physical fitness capable of enduring physically difficult, highly stressful situations, which may include the necessity to walk long distances, to eat a limited diet and/or to reside in potentially uncomfortable housing or tents. The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- The duties of the job require regular job attendance at least five days per week. Must be available to work outside normal office hours or on the weekends as required.
- Must be able to travel as required in any part of the Country where the team will be deployed. While performing the duties of this job in the field, the employee may be exposed to precarious settings under high security risks and/or very basic living conditions and outside weather conditions, as well as infectious diseases.
- As staff of Action Against Hunger the employees is required to engage with and follow the performance management program in place.
