- 1.3. You acknowledge that all documents submitted as part of your Expression of Interest (EOI) will become the property of Oxfam South Sudan and will not be returned to you.
- 1.4. All costs incurred in preparation of your EoI must be borne by you; Oxfam South Sudan will not be liable to reimburse any or all such costs.

2. Documents to be submitted

2.1 Submit an Expression of Interest (EoI) of not more than 10 pages.

THE TERMS OF REFERENCE

Background

Oxfam Background

Oxfam, an international non-governmental organization, has been actively engaged in humanitarian and development assistance in South Sudan for over 40 years. Our mission involves collaborating with others to alleviate poverty and reduce suffering. Our programmatic strategy focuses on saving lives, building resilient livelihoods, advancing gender justice, promoting good governance, and fostering active citizenship and promoting transformative education through a nexus approach that includes humanitarian response, development, and peacebuilding efforts. These initiatives are supported by robust policy influencing and advocacy capacities implemented in partnership with local and national nongovernmental organizations (NGOs). Currently, Oxfam operates in five field offices: Akobo, Nyirol, and Uror in Jonglei, Pibor in Greater Pibor Administrative Area (GPAA), Rumbek supporting Lake State, with its headquarters located in Juba, Central Equatoria State (CES).

Background of Local Humanitarian Leadership/localization and Partnership work.

Oxfam's partnership with local humanitarian organizations in South Sudan can be traced back to 2007 in Rumbek. During the period of stability and well-directed development agenda in South Sudan around 2012 to 2013, Oxfam scaled up its partnership ambition to various operation locations such as Upper Nile, and Jonglei. However, the national conflicts that occurred from 2013 to 2016 affected Oxfam's ambitions, leading to a shift towards direct implementation of humanitarian intervention with limited partner involvement. Despite the challenges, Oxfam continued working with partners on a smaller scale from 2013 to 2021, particularly in relatively stable regions, implemented scores of projects together.

From 2021 to the present, Oxfam has embarked on an ambitious scale-up effort, with a stronger commitment to localization in the Oxfam Country Strategy 2022-2026. This includes dedicated personnel and engagement with over 17 partners for the implementation of multiple grants.

The relationship with our partners has historically been transactional and tactical in nature. We however made deliberate journeying towards strategic and transformational partnerships with focus on jointly co-creating programs, embracing a high level of mutual accountability, enhancing partners' capacity, sharing risks, and providing value-added support, while ensuring increased funding for effective delivery and operational costs and implementing strategic partnership with partners with demonstrated capacity.

Purpose of the scoping.

Oxfam in South Sudan organized capacity scoping of women led Organization with aim to increase at least five (5) feminist organization to its partnership.

3. The submitted EoI must be from NNGO; any EoI that comes from INGO,						
consultancy firm, company limited etc with no proof of charity work will						
not be long listed and document not considered for review,						
4. All NNGO who have satisfied basic standard will be long listed and given chance for the evaluation committee to assess their EoI document.
