# REQUEST FOR QUOTATION NOTICE (VARIOUS LOT)

Universal Intervention and Development Organization (UNIDOR) in partnership with Christian Aid South Sudan (CASS), is implementing a project: Emergency livelihood support provided to food insecure and displaced households in Panyijiar County while responding to the very vulnerable with cash transfer along with provision of agricultural tools and seeds, in Unity state.

Therefore, it saves lives of conflict affected communities through cash transfers, inputs provision, and food security and livelihoods, therefore, the project seeks to avert dire food security situation in panyijiar county (Nyal, Kol and Mayom payams) through provision of multipurpose cash transfers.

#### THE PURPOSE

Through this request for quotation, UNIDOR seeks to secure competitive Bids for the selection of a company to supply goods and services. Eligible and qualified and competent companies are invited to apply through submitting quotations.

#### LOT I:

Transportation and distribution of cash to 400 beneficiaries in panijiar county (Nyal, Kol and Mayom payams)

#### UNIDOR'S OBLIGATION:

Reimburse the service provider in USD after completion of the distribution of cash in SSP.

Provide the service provider with the distribution statistics (list of beneficiaries or staff including amount designated per perform).

Support the service provider in the identification of beneficiaries and making sure that the beneficiaries have signed correctly and provide the needed identifications and telephone numbers where necessary.

#### **TERMS AND CONDITIONS:**

- 1. Bidders must have the financial capability needed to pre-finance the payment.
- 2. Security, transportation, accommodation to and from project sites will be cover by the company.
- 3. Bidders must provide a detailed implementation plan or mechanism on how they intend to accomplish said activity.
- 4. Interested bidders must be registered, and holder of a valid permit licensed to operate as a FSP from Bank of South Sudan (BOSS). Bidders without valid permits are automatically disqualified.
- 5. Bidder must have adequate number of staff to ensure service delivery in time and be able to meet insurance coverage for staff and funds.

- 6. Cash to be delivered to beneficiary cannot be worn out or torn, preferably new notes.
- 7. It is the sole responsibility of the contractor to acquire the necessary permits/clearance of cash and transportation of cash to all the field locations as it is required according to the law of South Sudan. The service provider shall be responsible for his/her income tax and/or insurance during the assignment.
- 8. The service provider should specify the Currency of offer -USD
- 9. Service provider should clearly specify the number of days required to assemble and deliver the required cash to the field (Mayardit North)
- 10. Validity of the offer should be min 3 months
- 11. Payment terms will be within 30-60 business days after receipt of service and invoice, by cheque.
- 12. A reference lists.
- 13. Provide the most recent Audited financial statements of its accounts.
- 14. Business Contact details including President/Owners of the company.
- 15. Clearly state the percentage of the commission Charge if any and the rate used for conversion of cash from USD- to SSP during Invoicing and what each beneficiary will be entitled too.
- 16. Annual Turnover of between \$100,000-\$200,000.

## LOT2: AGRICULTURAL SEEDS AND TOOLS

- 1. Provide legal required documents of the company as follows;
  - Copy of valid Certificate of tax clearance,
  - Copy of the company's certificate of incorporation,
  - Copy of Chamber of Commerce registration,
  - Copy Tax Identification Certificate,
  - Bank account details preferably where the money would be paid.
  - Copy of Certificate of Operation,
  - Company's official address,
- 2. Bids must be valid for minimum 3 months
- 3. Payment terms shall be within 30 working days after receipt of goods and invoice, by cheque.
- 4. Recommendation letters from 5 NGos/ Companies from which similar services have been provided.

- 5. Provide a seed germination certificate/
- 6. Provide the most recent Audited financial statements of its accounts.
- 7. Business Contact details including President/Owners of the company.
- 8. Ability to deliver all the above items to the partner offices.
- 9. Should specify the currency of offer and Mode of payment.
- 10. UNIDOR is not subject to VAT; therefore, all offers should be exclusive.
