INTRODUCTION

With funding from IR USA, IRSS is currently implementing project "Early Recovery and Resilience Program for Communities affected by conflict in South Sudan (ERRP)". Under this project, 1000 vulnerable households including household whose children are enrolled in nutrition program would have increased poultry production and income. In order to realize this, Islamic relief intends to procure 3000 chickens (2000 Pullets and 1000 Cockerels) and 10 bags of preliminary feeds to stabilize the chicken on arrival to 2 Poultry waiting centers before distribution to the beneficiaries.

The Overall Goal: The objective of this project is to strengthen poor households' livelihoods and resilience in Wau and Kapoeta East County.

HYBRID CHICKENS REQUIREMENTS

- 2.1 Breed: Kuroiler (dual-purpose hybrid breed) are preferred because of their hardiness and their Tolerance to all climate (hot or cool). F1 Breeds is preferred
- 2.2 Health: The chick should be healthy, i.e. actively eating, with good vision, hearing and breathing and free from pest and diseases. There should be no major physical injuries and no limping. The County Veterinarian Officer shall certify and issue a bill of health for the Poultry purchased.
- 2.3 Age: Pullets and Cockerels of 2 3 Months (8 weeks 12 weeks) are preferred because of their ability to cope up with changing environment.
- 2.4 Vaccination: All the chicken has to be vaccinated on Marek, Gumboro, Newcastle, Fowl Pox, Fowl Typhoid before the supply and possibly evidence for the vaccination have to be availed.
- 2.5 Temperament: Feeds continuously, friendly and scavenge well.
- 2.7 Types of feeds: 10 bags of preliminary feeds to stabilize the chicken on arrival before distribution to the beneficiaries.

2.7 Stabilization centers are expected to be Identified by the supplier and also transportation to the final distribution site is a responsibility of the vendor.

All tenders are required to be submitted before Tuesday Friday 19th March 2021 4.00pm (Local time) pursuant to the attached guidelines for submitting a quotation and be returned to; **IRSS TENDER BOX hand delivery is preferable** upon registration on the bid receipt form.
