It will be conducted in Rumbek (representing Lakes State) and Malakal (representing Upper Nile State) in South Sudan.

# OVERALL OBJECTIVES OF THE JOB:

BBC Media Action is recruiting two Research Freelancers to support the research activities. The research freelancers will be part of a team based in Juba and will be required to travel to the selected areas for data collection.

# Main Duties:

The main duties of the Research Freelancers will include but not limited to:

- Coordinate with community mobilizers to recruit suitable participants.
- Attend a training on qualitative research and other relevant policies.
- Moderate focus group discussions and in-depth interviews.
- Come up with debrief notes after the focus group discussions and indepth interviews
- Hold frequent debriefs with the BBC Media Action throughout the research period
- Conduct data transcription.

# PERSON SPECIFICATION - REQUIRED KNOWLEDGE, SKILLS AND EXPERIENCE

## Essential knowledge, skills and experience

- Experience conducting qualitative research, especially in rural setting.
- Attention to detail and the ability to work accurately.
- Ability to manage own workload and good time management skills.
- Strong ability to communicate with different members of the team.
- Fluent in spoken and written English language and at least one other local language.
- Have completed Diploma or Degree.
- Should bear South Sudanese National ID and be able to produce it
- Able to travel to areas outside Juba.

## Desirable Knowledge, Skills and Experience

- Degree/Diploma in Mass communication
- Experience working with media organizations in applied research.
- Working experience of not less than 3 years in Radio Programme production including PSAs with track record of working as radio station practitioners in the above-mentioned required areas.
- The individual being contracted should be able to demonstrate their expertise and practical approach used over the years in carrying out practical radio PSA production.
