The overall goal of SHARED is to ensure that crisis affected HHs have reduced food insecurity and malnutrition in SHARED operational counties by April 2024.

- Supervise Field Extension Agents (FEAs) on a daily basis to ensure agriculture, livestock, and fisheries livelihood activities are implemented at the same pace within target Payams.
