The closing time for submission of bids is **12:00pm** CAT on Thursday, **28th March 2024**. Bids must be sealed in an envelope clearly marked with the bid number and title given above, and submitted to **SCC Secretariat** in Sherikat, placed in the **SCC Bids Box**. Remember, Telephone calls; e-mail and late bids will not be accepted.

Bids must remain valid for a period of twenty (20) days after the closing date of the bid. **SCC** reserves its right to extend the validity period, should you not be willing to hold your bid valid in all respects for further period as requested, it will lapse on expiry of the current validity period.

Bids will be opened on the same day by the **SCC** and project **Engineering Unit** at 05:00pm CAT. Late or unmarked bids will not be considered. Bids may only be submitted on the bid documentation that is issued by SCC.

Tenderers must achieve a minimum of **6 points** out of a possible **10 points**. Bids which will be evaluated according to the standard evaluation system set by SCC. All bids are subject to a thorough scrutiny Pertinent to **committee's procurement and tendering Policies.** The Committee also reserves the right to withdraw any invitation to bid in a state of non-compliance to the required dossiers.

The Committee reserves the right to withdraw any invitation to bid and/or re-advertise or to reject any bid or to accept a part of it. The Committee does not bind itself to accept the lowest bid or to award a contract to the Bidder scoring the highest number of points. Additional requirements for sealing, addressing, delivery, opening and assessment of bids are stable in the Tender Document (As shall be provided by the SCC).
