Tender documents are collected upon payment of non-refundable fees of SSP500,000 for Big Generator, SSP100,000 for Small Generators, SSP 40,000 for Fridges, SSP40,000 for ICT Items (except CPU, Monitor, small UPS Battery and small Scanner shall cost SSP20,000) and SSP40,000 for Televisions. All the Non-refundable fees mentioned above, shall be paid to the Procurement unit at the Ministry of Water Resources and Irrigation.

The highest bidder has to pay the full amount on bids within allocated duration as stipulated by the Director General for Administration and Finance of the Ministry of Water Resources and Irrigation. This tender is open to all qualified bidders including staff of the Ministry of water Resources and Irrigation. Instalment Payments shall be allowed for the ministry staff only in Two (2) Bids not exceeding Three (3) Weeks and at least 50% payment of the first instalment. Extension of bid payment period may be authorized by the Director General for Administration and Finance with approved request letter from the disposal committee.

Individual interested in purchasing the above mentioned Assets may submit their highest quotation in the enclosed Performa in a sealed envelope addressed to Department of Procurement Ministry of Water Resources and Irrigation Juba South Sudan before 14<sup>th</sup> March, 2025 at 2:00pm CAT at the Ministry of Water Resources and Irrigation Head office at Hai-Cinema.
  - b. The bidders or their representative, not more than one for each quotation may be present if they so desire at the time of opening of the quotations.
  - c. The bidders should clearly indicate on the subject "Quotation for purchase (Name of the Asset or Assets)" if you are purchasing more than one asset
  - d. The quotation received on time will be opened at 2:00pm on any working day from 14<sup>th</sup> March, 2025 to 18<sup>th</sup> March, 2025 at the ministerial premises in the office of Procurement department.
  - e. The Assets will be available for inspection between **8:30am to 5:00pm** on any working day between **27<sup>th</sup> February, 2025 and 7<sup>th</sup> March 2025** at the Ministry premises.
- 2. The auction of stated Assets will be governed by the following conditions:
  - a. The Assets will be disposed off, on "as is where is basis" and no guarantee for its worthiness or quality will be given by the department of procurement at the ministry.
  - b. The bidders are required to pay earnest money SSP500,000 for Big Generator, SSP100,000 for Small Generators, SSP 40,000 for Fridges, SSP40,000 for ICT Items (except CPU, Monitor, small UPS Battery and small Scanner shall cost SSP20,000) and SSP40,000 for Televisions listed in the tables stated.
  - c. The earnest money shall be paid in **cash** to the department of procurement of the Ministry of Water Resources and Irrigation.
  - d. There shall be a receipt issued upon payment of the **earnest money** and should be attached along with the quotation during submission.
  - e. Quotations received without receipt of the **earnest cash receipt** will not be considered and will definitely be rejected upon submission.
  - f. The highest bid for the quotation of the condemned Asset will be decided as successful bidder.

- g. The successful bidder will be required to pay full payment of the amount on the bid to the finance department otherwise by following terms of payment as instructed by the finance department.
- h. Delivery of the auctioned Assets will be arranged after the bidder has successfully finalized payment of all dues as demanded by the finance department of the ministry.
- i. Papers related to ownership of the condemned assets will be provided by the legal counsel of the ministry of water resources and irrigation or as directed by the Director General for Administration and Finance thereto.
- j. The condemned Assets will be physically handed to the selected bidder upon completion of the payment and documentations regarding ownership had been duly confirmed by the Director General for Administration and Finance and that any issue relating to unfitness of the Asset shall completely not be entertained.
- k. The Asset will be collected by the successful bidder at their own cost. If delivery of the Asset is not taken with 15 days of the completion of all formalities, there shall be ground rent of **SSP200,000** (two Hundred thousand South Sudanese Pounds only) per a day spent after the 15 days elapsed.
- The department of procurement will not be responsible in whatsoever capacity after physical delivery of the condemned Asset to the selected bidder in case any outward incident happens afterwards.
