1. BACKGROUND OF ORGANIZATION

Formed on 1st of May 2022, as merger of two International Non-governmental Organizations operating in South Sudan, ZOA and Dorcas South Sudan, is a non-governmental Christian humanitarian development organization with a special focus in supporting refugees, internally displaced people, returnees and others who suffer from armed conflict or natural disaster by giving relief, hope and recovery to rebuild their livelihood. ZOA Dorcas South Sudan is active in the sectors of FSL, WASH, Community Development, Capacity Building, Education, TVE, Trauma Counselling and Psychosocial Support, Advocacy and Peace Building with a mix of early recovery programming where possible and humanitarian programming where necessary.

2. THE OBJECTIVE OF THE CONSULTANCY

Under a Civil Society Facility Phase II project funded by Mott McDonald, ZOA Dorcas, is supporting implementation of civil society organization (CSOs) capacity building project in Bor South County of Jonglei State of South Sudan which begun from 25 July 2022 to July 24, 2023. The objective of the project is to strengthen the organizational capacity of identified Civil Society Organizations (CSOs) in Bor South County to increase effective and sustained engagement with local authorities and decision-makers to identify and jointly address community needs".

This call for a consultancy service is to map the landscape of Civil Societies Organizations (CSOs) in Bor town in order to increase the understanding and fostering of collaboration and engagement of the civil societies in a network. The consultant is expected to deliver a research report that explains the landscape of CSOs by focusing on the following features.

- 2.3 The linkage between CSOs and their constituencies and the extent by which CSOs represent the interests of the constituencies.

3. SCOPE OF WORK

The consultant will select a suitable methodology for conducting the mapping of the landscape of civil society organizations (CSOs) and will focus the research on the objective. The proposed target of the research is the authorities (RRC, ministries, county), market leaders, the constituencies, faith groups, community leaders, CSOs project beneficiaries.

The consultant will review strategies CSOs and their engagement in advocacy and lobby with local authorities and the communities in the decision-making process.

Specific activities of the research

- 1. Review content of the research and update the proposed work plan with the technical coordinator
- 2. Review and agree on methodology and update the proposed action plan
- 3. Meet the proposed stakeholders/ target of the research
- 4. Compile and present a summary of report findings using a power point
- 5. Submit final finding Report
